The Florida Department of Economic Opportunity (DEO) on Thursday submitted the <u>Florida Strategic Plan for Broadband</u> to Gov. Ron DeSantis, Senate President Wilton Simpson, and House Speaker Chris Sprowls detailing the goals and strategies to improve and expand broadband Internet connectivity in Florida.



The terms of Commissioner Gary Clark and Commissioner Gabriella Passidomo are slated to expire in January, though they can apply for reappointment to the utility-regulatory commission. The application deadline originally was June 22, but it was extended to July 6.

- 'FREEDOM WEEK' ENDS: The state will end a "Freedom Week" sales-tax holiday that allows people to avoid paying sales taxes on a wide variety of purchases involving entertainment and recreation. For example, they will not have to pay sales taxes on tickets to movies and sporting events and on many types of boating, camping and fishing supplies. The holiday started July 1.
- PSC: The state Public Service Commission will take up a series of issues, including a proposal by Florida Public Utilities Co. to collect additional money from customers because of higher-than-expected fuel costs. (Thursday, 9:30 a.m., Betty Easley Conference Center, 4075 Esplanade Way, Tallahassee.)
- SUPREME COURT RELEASES OPINIONS: The Florida Supreme Court is scheduled to release weekly opinions. (Thursday, 11 a.m.)
