Proviso Requiring Oct. 1 – Minimum Wage Being Challenged as Unconstitutional

The Legislative Proviso language requiring Medicaid providers to implement a \$15 minimum wage by October 1 is being challenged by the Florida Ambulance Association, the Florida Assisted Living Association, and the Home Care Association of Florida. The challenge is requesting a temporary injunction enjoining the State of Florida and the Florida Agency for Health Care Administration from

enforcing the provisions of HB 5001, the General Appropriations Act for Florida State Fiscal Year 2022-2023 ("Budget") which creates effective January 1, a new cause of action against Medicaid providers who do not pay "direct care employees" a minimum of \$15.00 per hour. A second pleading is requesting a declaration that the court rule that the proviso language creating a new legal cause of action against Medicaid providers is unconstitutional and invalid. Attached are two documents that have been filed by the plaintiffs. The third document is a report of the impact of the proviso language on small counties in Florida.

Gas Tax-Break Starts Oct. 1 -

\$200 million in Federal funds allocated by Legislature to reduce price of gas!

Prices at the pump for Florida motorists should go down Saturday as part of a temporary gas-tax break, as 27 new laws kick in this weekend. The Legislature directed \$200 million in federal COVID-19 stimulus money to make up for the lost tax revenue. The decision to delay the tax break until October was based on the rationale that there would be fewer tourists in Florida than during other months. The gas-tax break was part of a larger tax package (HB 7071) that was passed by the Legislature in May. The average price of a gallon of regular unleaded gas in Florida hit a high of \$4.89 on June 13, but prices steadily declined during the summer, with the average at \$3.39 on Thursday, according to the AAA auto club.

Impact of Ian should note impact prices at the pump!

AAA spokesman Mark Jenkins said that since the storm was not "projected to impact the refineries in Louisiana, Mississippi and Texas, it's unlikely that the storm itself or the resulting demand, would cause pump prices to spike."

- MINIMUM WAGE GOES TO \$11: In the second increase under a 2020 constitutional amendment, Florida's minimum wage will go to \$11 an hour on Friday. The voter-approved amendment, spearheaded by prominent Orlando attorney John Morgan, will gradually lead to a \$15-an-hour minimum wage on Sept. 30, 2026, and inflation-linked increases after that. Under the measure, the minimum wage went to \$10 an hour on Sept. 30, 2021, and will increase by \$1 each Sept. 30 until 2026.
- TRANSGENDER TREATMENTS: A joint committee of the Florida Board of Medicine and the Florida Board of Osteopathic Medicine will discuss a draft rule that could restrict doctors from providing treatments to transgender people under age 18. The meeting will come after the Florida Department of Health in July filed a petition seeking a rule-making process on the contentious issue of treatment for gender dysphoria. The petition proposed what is known as a "standard of care" that would prohibit patients under age 18 from receiving sex-reassignment surgery and puberty-blocking, hormone and hormone "antagonist" treatments. It also would require that older patients sign a consent form and then wait 24 hours before starting such treatments.
