# **Elected Official Salaries for FY 22-23**

# County Salary History from FY 1985-86 to FY 2022-23

Additionally, EDR has updated historical summaries listing the annual formula-based salaries of each elected county and school district officer by county for the period of FY 1985-86 through FY 2022-23.

The Office of Economic and Demographic Research (EDR) calculated the salaries based on the Annual Factor and Cumulative Annual Factor, pursuant to s. 145.19(2), F.S. The certified factors for FY 2022-23 are: 1) Annual Factor, 1.0700; and 2) Cumulative Annual Factor, 3.6524.

Annual increases or decreases in elected officials' salaries are based in large part on annual changes in countywide population and the certified Annual and Cumulative Annual Factors. Consequently, the amount of annual salary increase or decrease in any given year varies by county and officer.

Pursuant to s. 145.021(1), F.S., the term "population" means the latest annual determination of population of local governments produced by EDR and provided to the Governor's Office in accordance with s. 186.901, F.S. Consequently, the official April 1, 2021 countywide population estimates were used to calculate the FY 2022-23 salaries because these estimates reflect the latest annual determination of population of local governments produced in accordance with s. 186.901, F.S.

Although 26 counties had April 1, 2021 countywide population estimates that were less than the corresponding April 1, 2020 estimates, there were no salary decreases for any elected officer in any county when comparing the formula-based FY 2022-23 salaries to the prior year's figures.

- MINIMUM WAGE GOES TO \$11: In the second increase under a 2020 constitutional amendment, Florida's minimum wage will go to \$11 an hour on Friday. The voter-approved amendment, spearheaded by prominent Orlando attorney John Morgan, will gradually lead to a \$15-an-hour minimum wage on Sept. 30, 2026, and inflation-linked increases after that. Under the measure, the minimum wage went to \$10 an hour on Sept. 30, 2021, and will increase by \$1 each Sept. 30 until 2026.
- TRANSGENDER TREATMENTS: A joint committee of the Florida Board of Medicine and the Florida Board of Osteopathic Medicine will discuss a draft rule that could restrict doctors from providing treatments to transgender people under age 18. The meeting will come after the Florida Department of Health in July filed a petition seeking a rule-making process on the contentious issue of treatment for gender dysphoria. The petition proposed what is known as a "standard of care" that would prohibit patients under age 18 from receiving sex-reassignment surgery and puberty-blocking, hormone and hormone "antagonist" treatments. It also would require that older patients sign a consent form and then wait 24 hours before starting such treatments.
