In Glades county – .14% of population remains without service.


## Distribution of \$175 million for Local Support Grants Put on Hold

## Link to List of Approved Project On Hold

The Joint Legislative Budget Commission last month **approved \$175 million for 238 local projects**. But Gov. **Ron DeSantis** has essentially put a freeze on those funds, halting the money from being distributed. The budget signed by DeSantis authorizing the Local Support Grants states "the Executive Office of the Governor shall submit an Administered Funds budget amendment no later than September 30, 2022, to distribute the funds for Local Support Grants to the appropriate state agencies for disbursement." The Governor's Office didn't submit a required budget amendment by the deadline to distribute \$175 million to agencies for local projects around the state. The governor's office hasn't commented on the reason for the decision not to submit the amendment, though the deadline came during a state of emergency for Hurricane Ian. The money now returns to state accounts. The Legislative Budget Commission is expected to meet next to approve another lump sum worth \$360 million to help the state recover from Ian.

As authorized in <u>section 197 of the FY 2022-23 General Appropriations Act</u>, members of the Legislature could request nonrecurring Local Support Grants for local governments, education entities, or privately-operated programs to support local initiatives. Projects requested for funding had to meet the definition of an Appropriations Project as provided in <u>House Rule 5.14</u>. Members had until July 15, 2022 to submit <u>Local Support Grant Request Forms</u>, and August 10, 2022 to submit <u>Attestation Forms</u>. The Joint Legislative Budget Commission met on Friday, September 9, 2022 to consider Local Support Grants for Fiscal Year 2022-23 among other business. 238 of the 971 requested projects were selected for consideration and subsequently adopted, totaling \$175,000,000 in funding.
