#### Organizational Session To Convene Tuesday

The Florida House and Senate will convene in Tallahassee next week to formally seat Senator Kathleen Passidomo as Senate President and Representative Paul Renner as the Speaker of the House for the 2022-2024 legislative term. Deliberations can be watched live on The Florida Channel.

# <u>House Speaker-designate Paul Renner announced the appointments of Rep. Michael Grant as</u> <u>Majority Leader and Rep. Chuck Clemons as Speaker Pro Tempore.</u>

Florida House Speaker-designate Paul Renner has announced the appointment of Representative Michael Grant as Majority Leader for the upcoming Legislative term. Renner also recommended Representative Chuck Clemons to the House leadership team as Speaker pro tempore for the upcoming Legislative term. As Majority Leader, Representative Grant will be responsible for guiding the Republican Conference and shepherding the Republican agenda throughout Committee Weeks and the Legislative Session. Representative Grant represents the people of House District 75, which includes parts of Sarasota and Charlotte County. He was recently re-elected to his fourth consecutive term. He also previously served as Majority Leader from 2020-2022.

As Speaker pro tempore, Representative Clemons will be responsible for performing the duties of the Speaker in the event of an interim vacancy of the Speaker through death, resignation, or disability. He will also preside in the Chamber when the Speaker leaves the Chair. Representative Clemons represents the people of House District 22, which includes Gilchrist, Levy and, part of Alachua County. He was recently re-elected to his fourth consecutive term. Recently, Representative Clemons served as Deputy Majority Leader and Majority Whip from 2020-2022.

#### Federal Judge Blocks the Stop Woke Act

Chief U.S. District Judge Mark Walker issued a ruling Thursday blocking the law that restricts the way race-related concepts can be taught in universities. The law, dubbed the "Stop Wrongs To Our Kids and Employees Act," or "Stop WOKE Act," lists a series of race-related concepts and says it would constitute discrimination if students are subjected to instruction that "espouses, promotes, advances, inculcates or compels" them to believe the concepts. Faculty members who violate the law, which has sparked several legal challenges, could be fired, and a "substantiated violation" of the restrictions would make schools ineligible for what is known as performance funding.

The law is "antithetical to academic freedom and has cast a leaden pall of orthodoxy over Florida's state universities," Chief U.S. District Judge Mark Walker wrote in the ruling. "Neither the state of Florida's authority to regulate public school curriculum, nor its interest in preventing race or sex discrimination can support its weight. Nor does the First Amendment tolerate it," he added.

Walker's ruling, which granted a preliminary injunction against the law, came in two lawsuits filed by professors and students from several state universities. The plaintiffs argued that the restrictions are causing confusion for instructors, are having a chilling effect on speech inside classrooms and are an unconstitutional infringement of professors' First Amendment rights.

### Did you know? 5,077 students involuntarily committed under Florida's Baker Act

#### 2021-22 State Involuntary Examination (IE) Report

Florida had 5,077 incidents of students being involuntarily committed under a mental-health law known as the Baker Act during the past school year, according to data presented Wednesday to the state school-safety commission. School districts are required to report Baker Act data under a law approved last year by the Legislature and Gov. Ron DeSantis. Districts report numbers of students who are taken to facilities because of incidents initiated on campuses, school transportation or school-sponsored activities.
