The Quick

Florida Senate and House on the Brink of Supermajorities

The Republican Party is within securing a two-thirds majority in both the Florida House and the Senate. The significance of that means that the GOP could override a governor's veto and essentially eliminate the procedural ability of the Democrats to pursue policy initiatives and pass legislation. Currently with slightly more than 1/3 of the House - Democrats have the ability to slow down the process. By the numbers –

- In the Florida House 80 seats comprise a two-thirds vote, meaning the GOP needs four more seats to achieve a supermajority; in the Senate, 27 seats constitute a supermajority, meaning the party needs to add four seats there, too.
- Republicans now hold 76 seats in the 120-member Florida House and Democrats 42 seats, with two vacancies. In the 40-member Senate, Republicans hold 23 seats and the Democrats 16, with one vacancy.


