#### The Quick

The Florida Legislature will gather Tuesday in the Capitol for an organization session. During meeting Naples Republican Kathleen Passidomo will formally become Senate president and Palm Coast Republican Paul Renner will take over as House speaker. The one-day session will be largely ceremonial, with members sworn in after the Nov. 8 elections. Passidomo and Renner should outline their priorities for the next two years. -Another significant note is that the GOP will hold a supermajority advantage in both the House and Senate which will make any effort by the Democratic members to challenge issues virtually impossible.
