Representative Harding Resigns from Office

Rep. Joe Harding has resigned from the Florida House effective immediately. He represented district 24, consisting of parts of Marion County. Harding is the subject of a federal grand jury indictment. The indictment includes multiple counts after authorities said <u>Harding illegally obtained \$150,000 in pandemic-related small business loans.</u>
