**State Board of Education to meet this week!**

The State Board of Education will meet Wednesday at the Nassau County School Board offices. The agenda is packed with presentations, update and proposed rules. Of note is a rule that would require school library employees to complete training sessions. This rule is designed, in part, to implement House Bill 1467 regarding certification of training of persons who select library materials aimed at part of a new law aimed at increasing scrutiny of library books and instructional materials. Also on the agenda is an update on the department's review of district salary distribution plans and districts' charter school salary distribution plans that were due by October 1, 2022. Select school district superintendents that are still in negotiations or at impasse with their local teachers' union may be required to provide an update to the State Board. Section 1011.62(16)(c)2., F.S., requires each school district to submit to the Department an approved district salary distribution plan, along with the approved salary distribution plan for each charter school in the district.

### **Florida Housing Finance Corporation's Ex. Director Announces Departure**

Florida Housing Finance Corp. Executive Director Trey Price is departing. The Florida Housing Finance Corporation (FHFC), is Florida's public-private partnership for affordable housing. Price has served as the FHFC Executive Director since March 2017. Price's resignation will take effect Feb. 1, one month before the 2023 Legislative Session convenes. New Senate President Kathleen Passidomo has named affordable housing a priority for her two-year term.
