Flagler Commissioner Donald O'Brien to Seek House Seat

Flagler County Commissioner Donald O'Brien announced this week that he's seeking a seat in the Florida House of Representatives. O'Brien, 63, is a Flagler County commissioner who's served in the commission since 2016. O'Brien is the first contender to emerge for the House District 19 seat. House Speaker Paul Renner currently holds the seat but can not run again due to term limits. O'Brien currently holds a seat on the Small County Coalition Executive Committee.
