Here are some of the issues that you may wish to communicate -

1. Implementation should not be done at the state level – the bill should be structured to authorize local communities to address this issue through referendum.
2. This should be left to the local community to determine what structure they have for local officials.
3. The bill is a restriction on the ability of local citizens freedom too choose the individuals they feel would be the best choice for their community.
4. The bill restricts the rights of citizens to choose their local elected officials without arbitrary time restraints.
5. Term limits don't guarantee better ideas-they simply term out expertise that the citizens of the county may wish to retain.
