Legislature:

- CITY AUDITS - Monday, 10 a.m. - The Joint Legislative Auditing Committee will consider requests for the auditor general to conduct audits of Delray Beach, White Springs and North Miami Beach. 412 Knott Building, the Capitol.
- IMPASSE ISSUES - Monday, 12:30 p.m. - The Joint Select Committee on Collective Bargaining will hold a hearing on issues at impasse with unions. Reed Hall, House Office Building, the Capitol.
- LGBTQ ISSUES - Monday, 1:30 p.m. - The group Equality Florida will hold a news conference to criticize Gov. Ron DeSantis on LGBTQ issues. Sen. Shevrin Jones, D-Miami Gardens, Rep. Anna Eskamani, D-Orlando, and Rep. Michele Rayner-Goolsby, D-St. Petersburg, are expected to take part. Fourth-floor rotunda, the Capitol.
- GUN-BUYING AGE - Monday, 3 p.m. - The House Criminal Justice Subcommittee will consider a proposal (HB 1543), filed by Rep. Bobby Payne, R-Palatka, and Rep. Tyler Sirois, R-Merritt Island, that would lower the minimum age from 21 to 18 to buy rifles and other long guns. The bill would reverse a change passed after the 2018 mass shooting at Marjory Stoneman Douglas High School in Parkland. 404 House Office Building, the Capitol.
- GAS STOVE PREEMPTION - Monday, 3 p.m. - The House Energy, Communications & Cybersecurity Subcommittee will take up a bill (HB 1281), filed by Rep. James Buchanan, R-Osprey, that would prevent local governments from restricting the use of gas stoves or other appliances. Reed Hall, House Office Building, the Capitol.
- DIVERSITY, TENURE - Monday, 3 p.m. - The House Postsecondary Education & Workforce Subcommittee will consider a proposal (HB 999), filed by Rep. Alex Andrade, R-Pensacola, that would make wide-ranging changes in the higher-education system. For example, the bill would prevent colleges and universities from spending money on diversity, equity and inclusion

programs and would allow university boards of trustees to review faculty members' tenure. Morris Hall, House Office Building, the Capitol.

- AMUSEMENT RIDE SAFETY- Monday, 3:30 p.m. - The Senate Agriculture Committee will take up a bill (SB 904), filed by Sen. Geraldine Thompson, D-Windermere, that would make a series of changes aimed at bolstering the safety of amusement rides, after a 14-year-old boy was killed last year in Orlando. 301 Senate Office Building, the Capitol.
- TECH ISSUES - Monday, 3:30 p.m. - The Senate Commerce and Tourism Committee will consider a proposal (SB 262), filed by Sen. Jennifer Bradley, R-Fleming Island, that would address a series of technology issues, including consumer data privacy. 110 Senate Office Building, the Capitol.
- **PRIVATE PRISONS**- Monday, 3:30 p.m. - The Senate Criminal Justice Committee will take up a bill (SPB 7016) that would shift oversight of privately run prisons from the Department of Management Services to the Department of Corrections. 37 Senate Office Building, the Capitol.
- TRANSGENDER TREATMENTS - Monday, 3:30 p.m. - The Senate Health Policy Committee will consider a proposal (SB 254), filed by Sen. Clay Yarbrough, R-Jacksonville, that includes preventing doctors from providing treatments such as puberty blockers and hormone therapy to transgender minors. 412 Knott Building, the Capitol.
- SPECIAL ORDER SET - Monday, 15 minutes after committee meetings end - The Senate Special Order Calendar Group will set a special-order calendar, which lists bills that will be heard on the Senate floor. 401 Senate Office Building, the Capitol.
- RULES COMMITTEE - Monday, 6:15 p.m. - The House Rules Committee will meet to set a special-order calendar, which lists bills that will be heard on the House floor. 404 House Office Building, the Capitol.

DeSantis last month nominated Michael Yaworsky, who began serving on an interim basis until DeSantis and the Cabinet could meet in their role as the state Financial Services Commission. Also, DeSantis and the Cabinet will consider spending nearly \$19 million to preserve 4,222 acres in Osceola County and 1,506 acres in Santa Rosa County Cabinet meeting room, the Capitol. DeSantis and Cabinet members will participate by phone.

Chuck Clemons, R-Newberry, that would create a public-records exemption for autopsy reports of minors whose deaths were related to domestic violence. Reed Hall, House Office Building, the Capitol.
- PATERNITY ISSUES - Tuesday, 8:30 a.m. - The Senate Children, Families and Elder Affairs Committee will take up a bill (SB 1146), filed by Sen. Clay Yarborough, R-Jacksonville, that

would make changes related to paternity and parental responsibility. 37 Senate Office Building, the Capitol.

- CHILD CARE FACILITIES - Tuesday, 8:30 a.m. - The Senate Education Pre-K-12 Committee will consider a proposal (SB 990), filed by Sen. Erin Grall, R-Vero Beach, that would make a series of changes related to child-care and early-learning providers. 412 Knott Building, the Capitol.
- VENOMOUS REPTILES - Tuesday, 8:30 a.m. - The Senate Environment and Natural Resources Committee will take up a bill (SB 1266), filed by Sen. Ana Maria Rodriguez, R-Doral, that addresses penalties for people who release venomous reptiles. 301 Senate Office Building, the Capitol.
- **NATURAL GAS TAX**- Tuesday, 8:30 a.m. - The Senate Transportation Committee will take up a bill (SB 322), filed by Sen. Joe Gruters, R-Sarasota, that would push back from 2024 to 2026 a natural-gas fuel tax. 110 Senate Office Building, the Capitol.
- BAKER ACT- Tuesday, 9 a.m. - The House Health Care Appropriations Subcommittee will consider a proposal (HB 829), filed by Rep. David Silvers, D-Lake Clarke Shores, that includes requiring the Department of Children and Families to annually update a handbook about the Baker Act, which sets legal procedures for mental-health examinations and treatment. Morris Hall, House Office Building, the Capitol.
- DIAPER TAX EXEMPTION- Tuesday, 11 a.m. - The Senate Finance and Tax Committee will consider a proposal (SB 114), filed by Minority Leader Lauren Book, D-Plantation, that would provide a sales-tax exemption for diapers, incontinence undergarments, incontinence pads and incontinence liners. 37 Senate Office Building, the Capitol.
- SEXUAL ORIENTATION, GENDER IDENTITY- Tuesday, 11:30 a.m. - The House Choice & Innovation Subcommittee will take up a bill (HB 1223), filed by Rep. Adam Anderson, R-Palm Harbor, that would bar instruction about sexual orientation and gender identity through eighth grade, expanding a controversial 2022 law that prohibited such instruction in early grades. The bill also would prevent school employees from telling students their preferred pronouns if those pronouns “do not correspond to his or her sex” or asking students about their preferred pronouns. Reed Hall, House Office Building, the Capitol.
- DEFAMATION LAWS - Tuesday, 11:30 a.m. - The House Civil Justice Subcommittee will consider a proposal (HB 991), filed by Rep. Alex Andrade, R-Pensacola, that seeks to revamp the state’s defamation laws. 404 House Office Building, the Capitol.
- AUTO GLASS REPAIRS - Tuesday, 11:30 a.m. - The House Insurance & Banking Subcommittee will take up a bill (HB 541), filed by Rep. Griff Griffiths, R-Panama City Beach, that includes preventing the practice of “assignment of benefits” in insurance claims for vehicle glass repairs and replacement. Morris Hall, House Office Building, the Capitol.
- **WASTE REDUCTION**- Tuesday, 1:30 p.m. - The Senate Agriculture, Environment and General Government Appropriations Committee will take up a bill (SB 506), filed by Sen. Linda Stewart, D-Orlando, that would require the Department of Environmental Protection to develop a waste-reduction and recycling plan. 110 Senate Office Building, the Capitol.
- CATALYTIC CONVERTER THEFTS - Tuesday, 1:30 p.m. - The Senate Criminal and Civil Justice Appropriations Committee will consider a proposal (SB 306), filed by Sen. Jim Boyd, R-Bradenton, that would take steps to curb thefts of vehicle catalytic converters. 37 Senate Office Building, the Capitol.
- SOCIAL MEDIA PLATFORMS- Tuesday, 1:30 p.m. - The Senate Education Appropriations Committee will take up a bill (SB 52), filed by Sen. Danny Burgess, R-Zephyrhills, that addresses

social-media issues in the education system, including seeking to prevent students from accessing social-media platforms while at school. 412 Knott Building, the Capitol.

- **SCHOOL BOARD ELECTIONS** - Tuesday, 3 p.m. and 4 p.m. - The House Education & Employment Committee and the Senate Ethics and Elections Committee will consider constitutional amendments (HJR 31 and SJR 94), filed by Rep. Spencer Roach, R-North Fort Myers, and Sen. Joe Gruters, R-Sarasota, that seek to move to partisan school-board elections in Florida. House meeting at 3 p.m., Morris Hall, House Office Building. Senate meeting at 4 p.m., 110 Senate Office Building, the Capitol.
- **BALLOT MEASURES** - Tuesday, 3 p.m. - The House Judiciary Committee will consider a proposal (HJR 129), filed by Rep. Rick Roth, R-West Palm Beach, that would make it harder to pass constitutional amendments. It would require approval of amendments by 66.67 percent of voters, up from the current 60 percent. 404 House Office Building, the Capitol.
