#### Week Three Two Major Priorities Pass – Universal Vouchers and Affordable Housing

#### HB 1 - Universal Vouchers and other revisions

Revises provisions relating to Family Empowerment Scholarship Program, Florida Tax Credit Scholarship Program, part-time enrollment in public schools, transportation of students, graduations requirements, Commissioner of Education duties, & educator certifications. Effective Date: July 1, 2023

#### SB 102 - Housing – 2023 – Affordable Housing

Citing this act as the "Live Local Act"; deleting the authority of local governments to adopt or maintain laws, ordinances, rules, or other measures that would have the effect of imposing controls on rents; providing an exemption from ad valorem taxation for land that meets certain criteria; authorizing local governments to adopt ordinances to provide an ad valorem tax exemption for portions of property used to provide affordable housing meeting certain requirements; suspending, for a specified period, the General Revenue Fund service charge on documentary stamp tax collections; authorizing the Governor, under the Florida Job Growth Grant Fund, to approve state or local public infrastructure projects to facilitate the development or construction of affordable housing, etc. APPROPRIATION: \$711,000,000 Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon becoming a law, this act shall take effect July 1, 2023

NEXT WEEK THE PROCESS WILL FOCUS ON BUDGET

Next week the House and Senate will focus on their respective budget proposals for the 2023-2024 fiscal year. With sufficient cash in the bank and revenue collections over projected level expect record spending. The Senate has released a \$113.7 billion proposal, while the House version weighs in at \$113 billion. The proposals will go before the Senate Appropriations Committee and the House Appropriations Committee on Tuesday. Beneficiaries of the record revenues – will be infrastructure projects; funding for Universal Vouchers; and, a record list of projects. Below are the House and Senate budget proposals.
