House and Senate to consider Appropriation Bills on Monday

Here are the current proposals for the General Appropriations Bill.

The House and Senate will consider budget proposals next week, as both budget committees are proposing record spending plans for the 2023-2024 fiscal year. The Senate proposal totals \$113.7 billion - the House package stands at \$113 billion. Both budgets exceed the \$109.9 billion budget for the current fiscal year, which ends June 30. After adoption by their respective chambers – the differences will be resolved after an Easter holiday break.

Major differences:

- The House has proposed cutting state funding from the tourism-marketing agency Visit Florida. The Senate wants to spend \$80 million on Visit Florida, up \$30 million from the current year and doesn't propose an increase in state guard funding.
- The House and Senate are proposing roughly \$26.6 billion for the Florida Education Finance Program. The total would represent a \$2.1 billion increase over the current year.
- The House and Senate differ in funding for Florida's school-voucher programs .
 - The Senate proposal funds the voucher system at \$2.2 billion, covering existing voucher students and new voucher recipients - \$802 million increase over the current year.
 - The House has projected that the voucher plan would cost about \$209.6 million. (Without knowing how many students will participate, both chambers set aside reserves to cover any potential voucher-system shortfall. The Senate set aside \$350 million, while the House put aside \$109.7 million.)
- The House and Senate both increase the transportation work plan to \$13.4 billion next fiscal year, up from \$12.6 billion in the current year.
- The Senate proposal provides \$564 million in Everglades funding and \$542 million for land-acquisition programs. The House proposal would spend \$568 million on the Everglades and \$251.2 million for land acquisition, of which \$100 million would recur annually.

The state Office of Public Counsel, which represents consumers, is challenging the Florida Public Service Commission's approval of the costs. The case involves an outage at Duke's Crystal River Unit 4 power plant that forced the utility to buy what is known as replacement power, according to court documents. Duke sought to collect \$14.4 million from customers to cover the replacement-power costs, but the Office of Public Counsel and representatives of business customers objected, arguing that Duke had mishandled the situation.
