Budget Conferencing to Start Monday Afternoon

House and Senate members are expected to start meeting in conference committees to
nail down details of the budget for the fiscal year that will start July 1. The House has
proposed a \$113 billion plan, while the Senate's version tipped the scales at \$113.7
billion — either of which would be a record. The spending plan needs to be finished May

2 if the session is going to end as scheduled May 5. That is because of a required 72-hour "cooling-off period" before lawmakers can vote on the budget.

FEFP Funding Formula Remains Unresolved House Proposal Repeals Sparsity and Categorical Funding Small School Districts Expressing Concern regarding loss of key funding programs

- There are major differences between the Senate and House proposed distribution K-12 Funding
- Conferencing will start Monday and it is a very real risk that direct funding for key programs will be repealed.
- The Senate uses the FEFP formula most aligned with current statutes, maintaining the Sparsity Supplement and 10 categorical elements.
- The House eliminates Sparsity funding and funding for 10 additional categories that have ensured specific funding for priority areas. The House rolls funding into the general formula exposing previously sequestered funds to collective bargaining process.
- Small districts benefit from categorical funding because it ensures an allotment enabling districts to implement priority areas with specific funding.
- The consolidation of categorical funding will eliminate the base funding component provided to each district a component that is critical to small districts meeting the program obligation.

House Term Limit Bill

• The Senate Rules committee will meet Monday at 1:00pm. On the agenda is HB 477 Term limits. This is the House version of the term limit proposal that only reduced the 12 year School Board term to 8 years. It does not address term limits for County Commissioners.

<u>Bills propose Preemption of Special Assessments on AG lands</u> <u>Small Counties request Offset</u>

• HB 1343, SB 1184, and SB 7084 all include language preempting the use of special assessments on lands classified as agricultural. The preemption will impact county revenues by an estimated \$23 million effective July 1, 2023 – although the House bill was amended to reduce the impact. The Small County Coalition is working to secure an offset of the revenue reduction for its fiscally constrained members.

<u>Bill Eliminating Enterprise Florida Moves Through Final House Committee</u> There is no Senate Companion to this House bill

House Bill 5 proposing to eliminate Enterprise Florida, Inc., (EFI) passed its final House committee. The bill provides that all duties, functions, records, pending issues, existing contracts, administrative authority, administrative rules, and unexpended balances of appropriations, allocations, and other public funds relating to the programs in EFI are transferred by a type two transfer to the Department of Economic Opportunity (DEO). The bill provides that VISIT FLORIDA and the Florida Sports Foundation may enter into agreements with DEO to continue any existing programs, activities, duties, or functions necessary for their operation. The bill provides for the repeal of the following programs and incentives; however, the bill authorizes continuation of payments for existing related commitments: -Urban High-Crime Area Job Tax Credit Program - Professional Sports Franchise Incentive -Entertainment industry tax credit - Motorsports Entertainment Complex - Capital Investment Tax Credit -Spring Training Baseball Franchises - Qualified defense and space flight tax refund - Retention of Spring Training Baseball Franchises - Qualified target industry businesses tax refund - International Game Fish Association World Center - Brownfield Redevelopment Bonus Tax Refunds - Florida Small Business Technology Program - High-Impact Sector Performance Grants - New Markets Development Program -Economic Gardening Programs - Microfinance programs - Quick Action Closing Fund - Economic Development Transportation Projects - Innovation Incentive Program - Office of Film and Entertainment - Florida Small Business Development Center Network - Florida Film Advisory Council - Scripps Florida Funding Corporation - Entertainment industry sales tax exemptions - Cooperative advertising matching grants program The Revenue Estimating Conference estimated the total state and local government positive revenue impact of the bill in Fiscal Year 2023-24 to be \$24.1 million (\$87.3 million recurring). In addition, funds from an EFI escrow account will likely be deposited into the State Treasury. The bill has an indeterminate impact on state expenditures, and no impact on local expenditures. The bill provides an effective date of July 1, 2023

Senate Tax Package Moves Forward

The Senate Tax Package -

- Permanently exempts the sale of the following products from sales and use tax:
 - o Machinery and equipment used to produce renewable natural gas.
 - o Baby and toddler products.

- o Diapers and incontinence products.
- o Oral hygiene products.
- o Firearm safety devices.
- Provides a 28-day "back-to-school" sales tax holiday over two separate time periods, from July 24, 2023, through August 06, 2023, and January 01, 2024, through January 14, 2024, for certain clothing, school supplies, learning aids and puzzles, and personal computers.
- Provides a 14-day "disaster preparedness" sales tax holiday from May 27, 2023, through June 09, 2023, for specified disaster preparedness items, supplies necessary for the evacuation of pets, and common household consumable items.
- Provides a 3-month "Freedom Summer" sales tax holiday from May 29, 2023, through September 04, 2023, for specified admissions, boating and water activity supplies, camping supplies, fishing supplies, general outdoor supplies, residential pool supplies, children's toys, and children's athletic equipment.
- Provides a 7-day "Tool Time" sales tax holiday from September 2, 2023, through September 8, 2023, for specified tools and safety equipment.
- Provides a 1-year sales tax exemption on the sale of:
 - o Specified ENERGY STAR appliances.
 - o Gas ranges and cooktops.
- Increases the Strong Families Tax Credit limit from \$10 million to \$20 million.
- Provides an additional \$150 million in tax credits for brownfield rehabilitation for use in Fiscal Years 2023-2024 through 2027-2028.
- Creates a corporate income tax credit for the installation of graywater systems on residential property.
- Creates a corporate income and insurance premium tax credit for the rehabilitation of historic real property in Florida.
- Distributes \$27.5 million for 2 fiscal years to the Florida Agricultural Promotion Campaign Trust Fund, from which it will be further distributed to the Florida Thoroughbred Breeders' Association and two thoroughbred racing tracks within Florida to be used to promote thoroughbred breeding and thoroughbred racing in Florida.
- Provides a credit against pari-mutuel taxes and fees for permit holders that conduct thoroughbred racing.
- Exempts certain portions of Small Business Administration loans from documentary stamp tax and intangible personal property tax.
- Exempts certain notes by alarm system contractors from documentary stamp tax.
- Permanently increases the sales tax dealer collection allowance from a maximum of \$30 per return to \$45 per return.
- Prohibits special assessments on agricultural lands.
- Requires several local taxes, when renewed or increased by referendum, to be placed on the ballot in a general election held within 48 months before the effective date of the renewed or increased tax, and prohibits them from being placed on the ballot more than once during that time period.
- Clarifies that the ad valorem exemption for disabled veterans may be transferred to other properties at the discretion of the disabled veteran or his or her surviving spouse.
- Expands the ad valorem refund for disabled veterans who purchase a new homestead in Florida after receiving the exemption on an existing homestead to no longer require the veteran to have been receiving the exemption on an existing homestead.
- Expands the homestead exemption for surviving spouses of first responders killed in the line of duty to include surviving spouses of federal law enforcement officers.

- Clarifies that parsonages, burial grounds, and tombs, when owned by a public house of worship, are used for religious purposes, and thus, are not subject to ad valorem tax.
- Amends the ad valorem exemption for educational property to include property under a 98- year lease by an educational institution and property leased by an educational institution and used by it for educational purposes if the property was owned by the educational institution and received the exemption for at least 10 consecutive years in the past.
- Amends the automatic property tax refund provision for residential property rendered uninhabitable to not apply when the damage was caused by an event resulting in a federal disaster area declaration or a state of emergency.
- Freezes local communications services tax rates in place on January 1, 2023, until January 1, 2026.
- Delays the imposition of the natural gas fuel tax from January 1, 2024, until January 1, 2026.
- Clarifies that when calculating the penalty for underpayment with regard to corporate income tax, a taxpayer's donation to a tax donation program is included as a payment of tax. The bill reduces revenues in total by \$1,198.2 million, which is the sum of \$420.5 million (recurring), and \$777.7 million (pure nonrecurring in Fiscal Year 2023-2024 and reductions resulting from nonrecurring impacts in future years). See Section V. Fiscal Impact Statement for additional information. Except as otherwise provided, the bill takes effect July 1, 2023.

State Terminates Contract Over Early Morning Alert Test!

The state of Florida is ending its multimillion-dollar contract with Everbridge a software company that emergency management officials said is responsible 4:45am morning alert test that blared from cell phones Thursday, rousing and angering Floridians across the state. There is some concern being expressed by local emergency managers that the termination action may jeopardize some of the capacity for early alert that has been established at the local level through the contract. Bottom line – accountability was swift!
