House and Senate On the Floor All Day this Week

- With five days left in the 2023 Legislative Session, the House and Senate are both scheduled to on the floor all day for the remainder of the 2023 Session You can follow along with the links provided below.
- A lot remains unsettled most importantly are the Budget bills and bills providing additional Economic Development for Rural Areas. It is anticipated that they will move forward this week but with the crush of bills competing for time you never know what will happen.
- A major piece of good news for local governments is the agreement on changes to the Florida Retirement System which was resolved last evening. The agreement is a fraction of the projected cost in the House's original proposal. See below an analysis from Bob McKee at the FAC.
- We are still working to secure a revenue offset for preemption of special assessments in the Ag. Lands bill. The proposed language is still in play but it's a toss-up as to it being included in the final budget document.
- Also in the budget agreement is \$5 million for a grant program that would fund a pilot program to help school districts push back the school start times for middle and high schools in the next few years. 2 Smalls, 2 Mid-sized, and 2 Large districts will be selected by the Dept. of Ed. The House has already passed the bill mandating that districts push back school start times in 2026.

Budget Conference Continues

SB 7204 – Retirement Benefits Settled

The following information is based on an analysis by the Public Policy unit of the Florida Association of Counties Although more information is needed before the actual cost is determined - it appears the impact of the agreement will be less than 10% of that of the House proposal. THE 3% COST OF LIVING INCREASE IS NOT A PART OF THE AGREEMENT. As a result, the impact is expected to be far less than estimates of the House bill!

Changes to FRS settled between House and Senate

The Senate offer specific to FRS may be viewed <u>here</u>.

Here's what in the agreement -

- 96 month DROP,
- Increase in interest rate during DROP from 1.3% to 4%

- Revised DROP Eligibility Window
- Revised Special Risk Retirement Date (Return to 25 years of service or age 55)
- Increase in the contribution rate to the Investment Plan by 2%

In the Budget Spreadsheet addressing all Administered Funds (available <u>here</u>), the following lines deal with the various FRS issues and are now closed out:

- Line 12 Florida Retirement System Contribution Adjustment (Note normal actuarial adjustment both House and Senate match on this Line item)
- Line 14 Florida Retirement System Investment Plan State Contribution (House \$14.6 M, Senate (\$29.3 M)
- Line 15 Florida Retirement System Pension Plan Benefit Enhancements (House \$468 M, Senate \$38.5 M)

Note – these are the costs to the State, not Counties; but County impact should also scale down similarly without the COLA piece, particularly since law enforcement officers were already allowed to extend to 96 month DROP.
