# **Budget** Agreement Reached

<u>The Budget Agreement will be released today!</u> As Soon As It Is Released – A Special Budget Edition will be Sent</u>

billion in spending which will cover state spending from July 1 of this year until June 2024. Although the budget agreement has not been published we know that the agreement boosts spending on teacher pay, sets aside hundreds of millions on environmental spending and increased reimbursements to some Medicaid providers.

Here's a glance at what's included:

- Increased the amount of money set aside for legal fights, including a highly-publicized battle with Disney including \$6 million in legal expenses for Gov. Ron DeSantis' office and additional money for litigation expenses in other state agencies.
- \$850 million to acquire more land for the Florida Wildlife Corridor designed to help preserve wildlife in a stretch of property that will run from Georgia and Alabama to the Everglades.
- \$400 million for a 5 percent across-the-board pay raise for state workers with an additional \$100 million in discretionary money for state agencies to use to give even bigger pay raises to keep state workers from bolting to the private sector.
- More than \$1 billion for construction projects and schools, universities and community colleges.
- more than \$200 million extra for teacher pay,
- money to bolster the recently-created Florida State Guard, and
- \$38 million to grant a one-time \$5,000 hiring and retention bonus for correctional officers working at 15 prisons to fill recurring job vacancies
- \$1 billion on a tax cut package although the details have yet to be finalized.
- \$80 million for Visit Florida

School Board Term Limits Reduced from 12 yrs. To 8 years Proposal for County Commission Term Limits not considered The Legislature has passed HB 477 reducing School Board Term Limits from 12 years to 8 years. The Senate voted 30-7 to pass the bill, with five Democrats joining Republicans in backing the measure. The House voted 79-29 in March to pass the bill. The Term Limit bill was just one of several bills targeting School Board members.

#### Other Bills impacting School Board members -

- <u>Non-Partisan to Partisan</u> The Legislature passed a proposed constitutional amendment that seeks to shift to holding partisan school-board elections. Lawmakers' approval put the measure on the 2024 ballot. If approved by voters, the amendment would do away with a requirement that school-board candidates run without party labels. Partisan elections could begin in 2026.
- **<u>Residency Requirement to Qualify</u>** Still under consideration is a proposal that seeks to change a requirement that school-board candidates have to live in the districts they are seeking to represent at the time they qualify to run. The proposal, which would require candidates to live in the districts at the time they assume office, needs House approval before it could go to DeSantis.

# **Economic Development Bills on Special Order**

Three Bills – SB 1482, HB 1209, and SB 1664 dealing with Rural Economic Development and Enterprise Florida are on Special Order scheduled for action in the Senate today and tomorrow.

SB 1482 and HB 1209 make changes to the Rural Economic Development programs including changes to match requirements and authorization for the state to pay invoices sent to rural counties located in rural areas of opportunity. SB 1664 is the proposal that eliminates Enterprise Florida and changes the name of the Department of Economic Opportunity to the Department of Commerce. The bills will have to sent to the House for final passage. The clock is ticking!

Note – Visit Florida is being transferred to the new Department of Commerce and is scheduled to receive \$80 million in the budget – a \$30 million dollar increase over current year.
