#### Hurricane Ian and Nicole - Proviso Language .docx

The Florida Division of Emergency Management will award up to \$350,000,000 to fund gaps in hurricane repairs and recovery to publicly owned facilities that were damaged in the hurricanes, infrastructure repairs, and loss of revenue within the counties that were declared for Hurricanes Ian and/or Nicole. The

application process will be open to city and county governments, independent special districts, school boards, charter schools, and State Universities.

The division will be accepting 4 categories of applications.

**1, Public Assistance will be funding for Local Governments that have, or will have, a Public** Assistance Project Worksheet on file. This

funding will be used as an advance payment or a 0% loan to get your projects started.

a. Types of Permanent Work Projects that you can apply for to be considered for a loan or an advance payment:

i. A PW that has a legislative member project that was introduced during this last legislative session and is associated to the work.

ii. A PW that is ready to start work, but you need funding to get started.

iii. A member project that doesn't have a PW associated with it, but could require a PW to be established because it is considered permanent work.

b. Member projects that are not considered permanent work but are related to hurricane repairs will also be considered. This will be a grant instead of a loan.

2. Infrastructure repairs for local governments that are not eligible for FEMA reimbursement.

Perhaps there are eligibility issues, you received a determination memo, or there was some other disqualifying reason.

a. Types of infrastructure repair projects that you can apply for to be considered for a grant:

i. Non-engineered beaches and dirt roads that are not maintained.

ii. Projects that have a determination memo.

3. Local and county revenue losses and operating deficits will be considered for grant funding when the DEO's Local Government Emergency Bridge Loan funding has been exhausted or upon

an applicant's denial of that program.

4. If there is funding still available, applications for a 50/50 match for *infrastructure repairs or replacement like roads, sewer, water facilities, beach renourishment, seawalls, or debris* 

*removal will be considered for grant funding.* Your jurisdiction will need to show that you have the funding for 50% of the project for the Division to grant the other 50%

5. Based on the type of project you are applying for; your grant manager may request additional information including, but not limited to:

a. FEMA Project Worksheets, Member projects.

- b. Previous 3 years of tax revenue and the current projected tax revenue.
- c. Proof of damages, pictures of damages, and estimates.
- d. Engineering recommendations, scopes of work.
- e. Determination memo(s).

f. If there is information that you have relating to your project that you think is important, please provide that information.

FDEM will be using DEMES for application submission and internal review. The DEMES portal opened on June 15, 2023, for application submission and the deadline is July 31, 2023. For more information regarding the Legislative Appropriations Program please visit

#### Supreme Court Committee To Review Consolidation of Florida's Judicial Circuits

In response to a <u>letter</u> from Speaker Paul Renner of the Florida House of Representatives the Supreme Court has issued a <u>proclamation</u> establishing a special committee to consider whether a consolidation of our state's existing judicial circuits is warranted. Renner's letter expresses that the current boundaries of our judicial circuits have been in place since 1969 and suggests that consolidation of judicial circuits might generate substantial cost savings and increase public trust and confidence in the judiciary through greater efficiency and uniformity in the judicial process.

In response – the Court issued a proclamation agreeing with the need to evaluate whether to consolidate Florida's judicial circuits. To that end, the Court has established a Judicial Circuit Assessment Committee and given the committee specific instructions and charges.

- The Committee must limit its findings and recommendations to whether there is a need to consolidate (i.e., reduce the number of) Florida's judicial circuits;
- In making its findings and recommendations, the Committee must assume that district court of appeal boundaries will remain unchanged;
- The Committee's findings and recommendations must be governed by the criteria set out in rule 2.241; and
- Before making its findings and recommendations, the Committee must confer with the chief judges and other representatives of the courts, court budget commissions, The Florida Bar, and the public, as required by rule 2.241, as well as with other justice system entities it deems appropriate.

The Committee will report its findings and recommendations to the chief justice, through the state courts administrator, by December 1, 2023.

Fifteen individuals are appointed to the Judicial Circuit Assessment Committee for a term to expire on March 29, 2024. The Honorable Jonathan D. Gerber will serve as Chair of the Committee. The Office of the State Courts Administrator will provide staff support.

Note – the inclusion of this item is a Head's Up for Small Counties in terms of the potential realignment/reduction of existing judicial circuits. The reduction of the number of circuits, if they are recommended, will be a decision of the Florida Legislature.

- LAWMAKER SUBPOENA CASE HEARD- Tuesday, 9 a.m. A panel of the 11th U.S. Circuit Court of Appeals will hear arguments in a dispute about whether 14 Florida legislators need to turn over documents in a challenge to a law restricting the way race-related concepts can be taught in universities. Attorneys for the state went to the appeals court after Chief U.S. District Judge Mark Walker on Feb. 22 rejected part of a request to quash subpoenas seeking information about the 2022 law, which Gov. Ron DeSantis dubbed the "Stop Wrongs To Our Kids and Employees Act," or "Stop WOKE Act." Plaintiffs in a constitutional challenge to the law subpoenaed documents from House members as part of an effort to determine if the measure was passed with a racially discriminatory purpose, according to court documents. 
