#### Of Note – Revenue Collections Continue to exceed Estimates

General Revenue collections for July 2023 were \$225.9 million (7.3 percent) over the estimates adopted by the General Revenue Estimating Conference (GR REC) in March 2023, as adjusted for law changes occurring during the 2023 Regular Session.

#### <u>Bill Proposes to put term limits for county commissioners on statewide ballot</u> Text of House Joint Resolution 19 - Term Limits for County Commissioners

As reported earlier, State Rep. Michelle Salzman has filed a bill seeking a vote to change the Florida Constitution and limit the terms of county commissioners to no more than eight consecutive years. House Joint Resolution 19 would prohibit incumbent county commissioners who have held office for eight years "from appearing on ballot for reelection."

Salzman indicated that House leadership was hoping to place term-limits on other local offices as well. No bill to expand term-limits to local officials other than county commissioners has not yet been filed. State Sen. Blaise Ingoglia, R-Spring Hill, has to file a companion bill through the legislature's upper chamber.

In order to be placed on the ballot, the term-limit proposal must be approved by 3/5ths of both the House and Senate. If the bill passes the Florida Legislature and is signed by the governor, the proposal would be placed on the ballot for consideration by voters. In order to be included in the Constitution, the proposal must garner 60% of the statewide vote in the General Election



#### Former Levy County Commissioner files to succeed term-limited Rep. Clemons

**Chad Johnson**, a professional auctioneer and former Levy County Commissioner, filed for the House District 22 contest to succeed Rep. **Chuck Clemons**. During his time as a county commissioner, Johnson was involved with the Small County Coalition. The district covers Gilchrist, Levy, and parts of Alachua counties. Johnson is stressing his own roots in the region.

"As a lifelong resident of the district and businessman, I understand the values and issues important to the working families of House District 22," the Chiefland Republican said. "In the state Legislature, I will work tirelessly for more jobs, better schools, conservation of our natural resources, and to protect the values of the Free State of Florida."

The guardian for Jacquelyn Faircloth went to the Supreme Court after a panel of the 1st District Court of Appeal rejected a \$28.6 million judgment in the case. Faircloth was injured when she was hit by a pickup truck in 2014 while crossing a street about 2 a.m., according to court records. The driver of the truck, 20-year-old Devon Dwyer, had been drinking at Potbelly's, a bar near the Florida State University campus, while Faircloth had been drinking at another establishment, Cantina 101.
