Idalia's Track Still Unclear – Latest model shows slight shift toward Central Florida.

Tropical Storm Idalia formed today and is expected to approach Florida as a hurricane this week. As of Sunday afternoon, Idalia was about 80 miles east-southeast of Cozumel, Mexico. The system had maximum sustained winds of 40 mph. The storm was moving east at 2 mph. "Idalia is moving toward the north near 2 mph, and it is likely to meander near the Yucatan Channel through tonight. A faster motion toward the north is expected on Monday, bringing the system over the eastern Gulf of Mexico," the NHC said. "Strengthening is forecast, and Idalia is expected to become a hurricane by Tuesday."

<u>Earlier computer models showed Idalia tracking over the panhandle, but on Sunday the path had moved closer to Central Florida.</u>

<u>Widespread opposition shared with Committee studying consolidation of the circuit court</u> system.


Earlier this summer, Supreme Court Justice Carlos Muniz appointed a committee to look at consolidation in the 20-circuit system. The action came in response to a request from House Speaker Paul Renner, R-Palm Coast. Florida Supreme Court Chief Judge Muniz issued an order June 30 appointing the committee after receiving a request from Renner.

The Judicial Circuit Assessment Committee met Friday to take input on the possibility of consolidating judicial circuits. The committee got an earful of opposition from prosecutors, public defenders, lawyers, retired court officials and others closely familiar with Florida's judicial system who expressed ued dire warnings about a proposed overhaul of the judicial system in Florida. Every person who testified opposed plans that could reduce Florida's judicial circuits from 20 to five.

What happens now? The Court Study Committee will conduct additional meetings to determine what recommendations will be sent to the Supreme Court. If the court determines that there is a need to increase, decrease, or redefine judicial circuits, it must certify its findings and recommendations to the Legislature. Florida Rule of General Practice and Judicial Administration 2.241 also sets out detailed factors for the court's consideration and gives an overarching instruction to "balance the potential impact and disruption caused by changes in judicial circuits...against the need to address circumstances that limit the quality and efficiency of, and public confidence in, the judicial process." Under the rule, before recommending a change in "judicial structure," the court must consider "less disruptive adjustments" to judicial branch operations.
