### ***Revenue Report Shows Continued Positive Growth***

#### ***August 2023 - Monthly Revenue Report***

General Revenue collections for August 2023 showed a gain of \$285.7 million (8.8 percent) against the newly adopted forecast assumptions made by the General Revenue Estimating Conference (GR REC) in August 2023, with the gain from a wide array of sources. After adjusting total Sales Tax collections for local taxes and distributions, audits, bad checks and transfers to Sales Tax from the Communications Services Tax, Sales Tax GR was \$136.9 million (5.1 percent) over the estimate for the month. August collections reflect activity that largely occurred in July.

### ***Coalition Calls For Regional Approach to Challenges Resulting from Idalia and the announced closure of the Georgia Pacific plant in Taylor County***

At its meeting on Wednesday, the Officers and Executive Committee of the Small County Coalition requested a regional approach to address the pressing challenges currently faced by many of the fiscally constrained counties in the N.E. Central segment of the Big Bend Region as a result of damage from Hurricane Idalia and the announced closure of the Georgia Pacific plant in Taylor County. The letter underscored that either one of the events alone would impact the economic stability of the “fragile” economies of the small counties, but both will cause long-term hardships for the hard-working people that live and want to stay in the region. 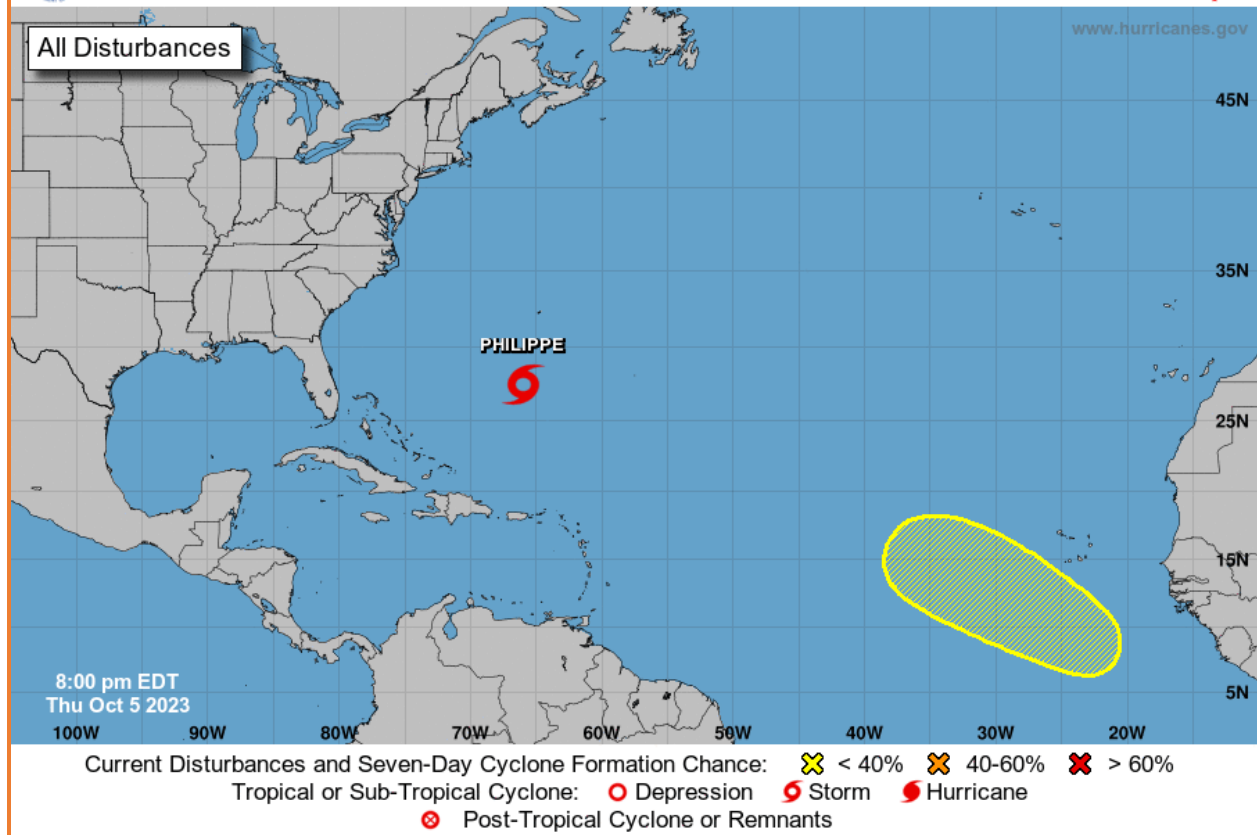
