Miami at FSU Tops the Bill

Senate and House Committees Move Special Session Bills Forward

Mondays Actions - Disaster Relief and Increasing Vouchers Committees Approve Idalia Relief Bills

Florida House and Senate committees moved forward two similar bills that provide disaster relief for counties hit by Hurricane Idalia. The bills provide more than \$400 million in relief, including \$176.2 million to clear a backlog on the My Florida Safe Home Program. The bills also provide property tax breaks for damaged agricultural equipment, including a processing facilities. Farmers representing groups such as the Florida Forestry Association, the Florida Fruit and Vegetable Association and the Cedar Key Aquaculture Association thanked legislators for helping the state's agriculture industry recover from Hurricane Idalia.

Senator Simon Issues Stern Warning to Georgia Pacific

In the Senate Fiscal policy – Senator Corey Simon presented SB 2C and issued a stern warning to Georgia-Pacific Corp. against anticipating to use the legislation to benefit their company. Georgia-Pacific closed its pulp mill and laid off more than 500 employees in September, a move that is economically devastating to Taylor County and the regions timber industry. Georgia-Pacific announced closure of its plant in Perry but the decision was not related storm damage. The Small County Coalition presented testimony in favor of the legislation in both the Senate and House committees.

Bills Increasing Voucher Program Move Forward

During the first day of Special Session C - House and Senate committees approved identical bills that will remove the cap that was set for the state-funded universal voucher program. The bills propose to remove the cap on the number of vouchers for the current school year and extend the window to apply for the vouchers until Dec. 15, allowing potentially thousands of new students access to the scholarships. The bills will enable potentially 9,000 additional students to participate in the program.

Deregulating Public Schools

In response to requirements in HB 1 passed in the 2023 Legislative Session the DOE, the House, and the Senate are exploring proposals to bring flexibility by eliminating an/or revising existing regulations governing K-12 public education. Today and tomorrow, Senate and House committees will hear presentations on DOE proposals and the Senate K-12 committee will consider additional proposals designed by a process that solicited changes. 
