Proposed Senate and House Budgets Go to Full House and Senate Floor Next Week

House Budget Documents

House released the full text of HB 5001 (General Appropriations Act), which was formerly PCB APC 24-01. The House Budget bill lists a figure for total spending of \$115,547,289,055.

Senate Budget Documents

The Senate released the full text of SB 2500 (Appropriations) and SB 2502 (Implementing Bill). The bills were formerly PCBs, and these new texts incorporate all adopted amendments. The Senate Budget bill lists a figure for total spending of \$115,939,248,697.

- The bills will be heard on the Floor February 7, 2024.
- The deadline for filing amendments to SB 2500 and SB 2502 is 1:00 p.m., Monday, February 5, 2024. (Suite 201, The Capitol)
- The deadline for filing amendments to amendments and substitute amendments to SB 2500 and SB 2502 is 1:00 p.m., Tuesday, February 6, 2024. (Suite 201, The Capitol)

K-12 Deregulation Bills

A major priority for this session has been the "deregulation" of unnecessary regulations that if deleted will provide additional flexibility for public school districts. In the Senate there are three bills 7000, 7002, and 7004. The House has bills that contain some provisions but are different. —

- SB 7000 dealing with issues related to Instructional, Administrative, and Support Personnel. The House bill HB 7039 differs but is the comparative bills to SB7000.
- SB 7002 deals with School District Finance and Budgets, Facilities, and Administration and Oversite. The House Companion HB 7039 differs but the following link provides a comparison.
- SB 7004 deals with Assessment and Accountability, Instruction and Education Choice. The House Companion is 7025 it differs.

Note – the chart linked above is great in showing the similarities and differences with the proposed legislation. It was designed by Bob Cerra.
