Ed Hooper, R-Clearwater, that would allow residents with homes valued at more than \$700,000 to get coverage from the state's Citizens Property Insurance Corp. Under current law, Citizens is barred from selling policies for homes with a "dwelling replacement cost" of \$700,000 or more, except in Miami-Dade and Monroe counties, where the limit is \$1 million. 110 Senate Office Building, the Capitol.
