Term Limits for County Commissioners is Dead for 2024

Thank you to the numerous local officials that came forward throughout the process.

After reaching the Senate Floor – the Senate Sponsor pulled the plug when it became clear that many members of the Senate continued to have concerns about the bill.

This will return next year – and we are challenged to work with our local communities over the interim to educate the importance of local control over structure and local leadership! But let's take a breath of relief and thank those that came forward and wrote letters raising questions about this legislation!

With 7 days left after today – the 2024 Session will be coming in for a landing next Friday

<u>Here's where we are – Budget Negotiations</u>

The Budget Conference is not done – it is in the hands of the Appropriations Chairs – Senator Broxson and Representative Leek. They are working out differences that could not be resolved during subcommittee negotiations. What next? If budget items remain unresolved the issues will be bumped up to the Senate President Passidomo and Speaker of the House Renner. If the session is to end on time the budget agreement must be on the desk no later than end of day next Tuesday.

Committee meetings are over – unless called by a waiver of the rules. Hundreds of bills are on the calendar of the House and Senate either awaiting consideration on Special Order or have been passed by either the House or the Senate and are in messages in either chamber waiting for final consideration.

The f link will provide the last action of any of the bills that we have followed. Many are still in play. Things are moving too quickly to say whether they will pass or not - so this is the best we can do for right now!

HB 0001	Online Protections for Minors - This bill has passed but the Governor has expressed concerns.
<u>HB 0003</u>	Online Access to Materials Harmful to Minors – This bill is still in consideration and will be amended to correct concerns expressed by the Governor about HB 1
HB 0087	Taking of Bears - Awaiting final action in messages from the Senate in the House.
SB 0184	Impeding, Threatening, or Harassing First Responders - In messages from the Senate
SB 0196	Economic Development - awaiting final action in House.
HB 0309	Rural Emergency Hospitals - Awaiting final action.
SB 0472	Suits Against the Government - Sovereign Immunity - this bill will be amended to be suitable to local to local governments or it will die.
SB 7002	Deregulation of Public Schools/School District Finance and Budgets, Facilities, and Administration and Oversight
SB 7004	Deregulation of Public Schools/Assessment and Accountability, Instruction, and Education Choice - Still in play.
<u>HB 7017</u>	Annual Adjustment to Homestead Exemption Value - Constitutional Amendment
<u>HB 7019</u>	Exemption of Homesteads – implementing bill that provides Fiscally Constrained county offset for 7017.
HB 7039	Education – House bill relating to deregulation. Something will pass.
<u>HB 7075</u>	Tangible Personal Property Tax Exemption – Constitutional Amendment increasing TPP by 25,000.
<u>HB 7077</u>	Tangible Personal Property Taxation - Implementing bill that provides Fiscally Cosntrained county offset for 7075.
