Senate Presidents Husband dies after fall!

The death of John Passidomo is being received with tremendous sadness. It is an unmeasurable loss to President Passidomo, their family, the Senate Family and people who worked with them. How quickly life can change - this past Monday afternoon, while hiking with the President in Utah, the First Gentleman, Mr. John Passidomo, fell and suffered massive trauma to his head. among other very serious injuries. After extensive evaluation over the next 24 hours, the President was advised that Mr. Passidomo would not survive these severe injuries. President Passidomo and their three daughters were by his side when the First Gentleman passed away peacefully Wednesday at 3:21 p.m. EDT. Mr. Passidomo was very fit and active, with overall excellent health at age 72. He was an organ donor and matches for several of the First Gentleman's organs were identified. The President and her family are taking comfort in the fact their great loss has resulted in a life-saving gift for other families. Our thoughts and prayers go out to the Passidomo family.

Status of Enrolled Bills that passed

Once a bill has presented to the Governor – he has 15 days to approve, veto, or let it become law without his signature.

The General Appropriation Act has not been sent to the Governor as of this moment.

Of the 325 bills passing the Legislature - 92 bills have been sent to the Governor for review:

- 57 Bill have been approved.
- 2 Bills have been vetoed.
- 33 bills have yet to be acted on by the Governor.

Another 222 bills, including the General Appropriations bill, have yet to be sent to the Governor.

There are Six Proposed Constitutional Amendments on the Ballot in November

There are six proposed constitutional amendments that will appear on the November General Election ballot. Here are brief descriptions of the six issues:

- ABORTION: Voters will decide whether to enshrine abortion rights in the state Constitution. The proposed constitutional amendment, in part, says: "No law shall prohibit, penalize, delay, or restrict abortion before viability or when necessary to protect the patient's health, as determined by the patient's healthcare provider."
- CAMPAIGN MONEY: Lawmakers approved placing the proposal on the ballot to try to repeal a program that offers state matching funds to gubernatorial and state Cabinet candidates. Voters approved the matching-funds program in 1998, and a repeal attempt failed in 2010.
- FISHING AND HUNTING: Voters in November will decide whether to enshrine a right to fish and hunt in the state Constitution. In part, the proposal says hunting and fishing "shall be preserved forever as a public right and preferred means of responsibly managing and controlling fish and wildlife."
- MARIJUANA: Voters will decide whether to give the go-ahead to recreational use of marijuana. The measure on the ballot would allow people ages 21 and older to "possess, purchase, or use marijuana products and marijuana accessories for non-medical personal consumption."
- PROPERTY TAXES: Homeowners could receive slightly larger property-tax breaks if voters approve this proposal. The proposal would adjust part of the homestead property-tax exemption for inflation. Homeowners receive tax exemptions on the assessed values of their property up to \$25,000 and on the values between \$50,000 and \$75,000. The proposal would require adjusting for inflation the exempt portion currently between \$50,000 and \$75,000.
- SCHOOL BOARD ELECTIONS: Voters will decide whether to hold partisan school-board elections. In 1998, voters passed a constitutional amendment to make school board races non-partisan. This proposal would return to partisan races starting in 2026.

In order to become part of the Constitution – the proposal must secure a 60% majority of the voters.
