Florida Tax Watch To Release The 2024 Budget Turkey Watch Report

Tallahassee-based think tank Florida Tax Watch will release The 2024 Budget Turkey Watch Report Wednesday. The annual report typically finds tons of turkeys that it suggests should be vetoed! Last year, Florida Tax Watch identified nearly/8600 million in spending inserted into the budget late in the negotiation process or that otherwise bypassed debate. The budget turkey list comes as the 2024-25 budget awaits approval. DeSantis has line-item veto power.

Emergency Declaration Expanded from 12 to for 15 Counties

Executive Order 24-95

Baker, Columbia, Escambia, Gadsden, Hamilton, Jefferson, Lafayette, Leon, Liberty, Madison, Okaloosa, Santa Rosa, Suwannee, Taylor, and Wakulla counties.

The emergency declaration gives authority to state Division of Emergency Management Director Kevin Guthrie to take a series of steps to help oversee response and recovery to the storm. Also it made available money from the state Emergency Preparedness and Response Fund.

The Budget – Nothing New

- Legislative Budget for 24-25 has not yet been presented to the Governors Office.
- The Governor is using this time to announce his support for many of the areas that are funded in the budget.
- This week the Governor held a press conference in South Florida on measures addressing the surge of Human Trafficking. Florida is recognized for the broad statutes and funding to address this horrible offense on vulnerable people
- Once the Budget is presented to the Governor -he has 15 days to sign, veto, or let it become law. Expect a slew of vetoes.

Florida High School Athletic Association To Consider NIL Program for Student Athletes

The Florida High School Athletic Association held a discussion Tuesday about a potential change to the organization's bylaws that would allow student-athletes to profit from their name, image and likeness under what is commonly known as an NIL policy. The 13-member board, which includes eight members appointed by Gov. Ron DeSantis in August, is slated to vote on the proposal during a June 4 meeting. The proposal would overhaul a part of the FHSAA's bylaws that govern "amateurism" in athletics. Schools and districts would have to remain on the sidelines in the deals, according to the plan. The Florida High School Athletic Association released the following **proposal** in February.
