#### Report Shows State Revenue Collections Continue to Exceed Monthly Forecasts

The Legislature's Office of Economic & Demographic Research has issued its monthly report on revenue collections. The collections of State general-revenue tax collections have exceeded projects again. Collections in May were 4.2 percent higher than expected. Collections in May totaled \$4.48 billion, \$182.4 million more than expected when a forecast was issued in January. Sales-tax revenue accounted for \$3.121 billion of the total collections, which was \$71.9 million more than forecast. Other general-revenue sources topping estimates were insurance taxes, earnings on investments and documentary-stamp taxes on real estate transactions. The next Revenue Estimating Conference will update the forecast in August.

#### Forecast for 23-24 Citrus Production Up but still below years prior to 22-23.

The U.S. Department of Agriculture released a forecast in June that showed overall citrus production in the 2023-2024 season expected to be about 11 percent higher than in the 2022-2023 season. But everything's relative: The 2022-2023 total was the lowest in more than nine decades.

## Forecast Adjusted up for Hurricane Season

Experts at Colorado State University on Tuesday increased their storm forecast for what was already expected to be an above-average hurricane season. The forecast now calls for 25 named storms this season, up from 23 when the first forecast was released in April. The projection of a U.S. landfall has dipped slightly, from 62 percent when the outlook was first released in April to 57 percent, according to

the department. Most years, the average is 43 percent. The landfall projection for the coastline that includes parts of Florida south and east of Cedar Key is now at 31 percent, down from the earlier 34 percent. Since 1880, the yearly average is 21 percent.

- The National Oceanic and Atmospheric Administration forecast up to 25 named storms, with as many as 13 reaching hurricane strength and four to seven packing Category 3 or stronger winds.
- The 2023 season was the fourth most-active on record with 20 named storms, including seven that reached hurricane strength and three major storms.
- By comparison, seasons from 1991 to 2020 averaged 14.4 storms a year, with an average of 7.2 reaching hurricane strength.


