The Budget for 24-25 is signed, sealed and delivered. Vetoes Come - Fast and Sharp

As reported yesterday afternoon, Governor Ron DeSantis signed the 2024-25 budget (<u>HB 5001</u>) and released his list of line-item vetoes totaling \$949,611,399. My crystal ball is cloudy as to the Why's relating to specific vetoes. The veto letter (below) doesn't really provide explanation but here are some observations:

- Vetoed Projects in 26 small counties ranging from school programs, septic to sewer, transportation, government facility projects.
- Vetoes by program areas
 - o Funding for Rural Enhancement Toolkit Pilot Program \$600,000
 - Funding for Arts and Cultural Grants \$26,000,000 this veto will impact funding for local arts organizations across the state.
 - Over six million in funding for the State Approved Cultural Facility list. While the approved project list was vetoed dozens of projects that skipped the agency review process remained funded.
 - o 16 Septic to Sewer Projects vetoed statewide.
 - o 58 Local road projects vetoed statewide.
 - o 30 Fire related projects vetoed statewide.
 - Over 40 water projects vetoed statewide. .
 - o 5 projects funding Boys & Girls Clubs vetoed in the state.
- The following list is not all inclusive for areas with multiple vetoes, however, it is noticeable that multiple projects were vetoed in the following areas where legislative leaders reside:
 - Hardee and Wauchula -8 projects vetoed
 - o Flagler and Bunnell-8 projects vetoed
 - Clay and Santa Rosa each had 6 projects vetoed
 - o Charlotte and Monroe communities had 3 projects vetoed.


