### Legislative Policy Platform Processes Underway!

Most of the relevant state organizations are beginning the development of proposals for legislative consideration.

- The Florida Association of Counties has outlined a process for County Commissioners to propose issues for consideration. Deadline for policy submittal is August 9 to submit a policy proposal go to this link <a href="https://flcounties.wufoo.com/forms/zon2c5v0l6c1nh/">https://flcounties.wufoo.com/forms/zon2c5v0l6c1nh/</a>
- The Florida Association of District School Superintendents and the Florida School Boards Association are all engaging in legislative program development. Links will be available soon.
- The Small County Coalition (<u>www.smallcountycoalition.org</u>) has begun preparing the 2025 Draft Proposal by reviewing the 2024 Program for revisions. The Coalition will also monitor the FAC process. Any item submitted to be considered in the Florida Association of Counties Policy Process that has relevance to small counties and rural communities will be considered for inclusion in the Coalition's 2025 Program.
- The Small School District Council Consortium (<u>www.ssdcc.org</u>) is also tracking developing issues for consideration. A Draft Legislative program will be developed for the SSDCC Officers and Executive Committee for consideration by the membership later this fall.

Annual Calculations for FY 2024-25 per Section 409.915, Florida Statutes are estimated to increase by 17.8%. For State Fiscal Year 2024-25, the counties' contribution to Medicaid calculations as determined by the Social Services Estimating Conference, growing \$311.9

# million (the total contribution for FY 2023-24) by 17.8% results in a new total amount of the counties' annual contribution of \$367.4 million for FY 2024-25.

## **BEBR Report shows Consumer Sentiment Improving**

According to survey conducted by the University of Florida Bureau of Economic and Business Research, consumer sentiment among Floridians increased for the second consecutive month in July, rising to 74.4 points, up 1.2 points from a revised figure of 73.2 in June. Conducted June 1 to July 25, the UF study reflects the responses of 229 individuals who were reached on cellphones and 273 individuals reached through an online panel, a total of 502 individuals, representing a demographic cross section of Florida. The index used by UF researchers is benchmarked to 1966, which means a value of 100 represents the same level of confidence for that year. The lowest index possible is a 2, the highest is 150.


