

Attorneys for the plaintiffs, St. Petersburg residents Alieda and Lawrence Maron, appealed after U.S. District Judge Robert Hinkle sided with state Chief Financial Officer Jimmy Patronis and dismissed the case. The lawsuit alleges that the state does not provide "just compensation," such as interest, to owners who ultimately claim property. It contends that the system results in an unconstitutional "taking" of property. The law involves people's property that has been held by such things as banks and insurance companies. Frank M.
