FLORIDA TAX HANDBOOK



2024 FLORIDA REVENUE ESTIMATING CONFERENCE

The Revenue Estimating Conference has released [the 2024 edition of the Florida Tax Handbook, Including Fiscal Impact of Potential Changes](#). The Handbook provides statutory and administering authority for all major revenue sources, a review of tax collections and dispositions, base and rate information, and a brief history of the individual sources. The Handbook provides current revenue estimates and presents a look at the revenue potential of selected alternative tax sources. The information can be used to analyze the revenue effects of proposals for tax relief, tax increases, dealer allowances, changes in exemptions, or alterations to the tax base. The staffs of the Senate Committee on Finance and Tax, the House Ways & Means Committee, the Legislative Office of Economic and Demographic Research, the Governor's Office of Policy and Budget, the Florida Gaming Control Commission, and the Departments of Revenue, Highway Safety and Motor Vehicles, and Lottery provided the various analyses and updates.

As specific legislation is identified during the course of each session, more in-depth analysis is undertaken which leads to revisions. The estimates presented in this book show the revenue impact as if the proposed tax law changes were in effect for the entire year. Normal delays caused by collection and implementation lags will reduce the actual revenue impact in the first year. Tax law changes that only affect revenues for part of a year will further modify the estimates. It should also be noted that estimates

presented in these analyses are based on historical data from annual collections through Fiscal Year 2023-24. As each session begins, Impact Conferences are held to consider specific legislative proposals. The results are at <http://edr.state.fl.us/Content/conferences/revenueimpact/index.cfm>.

Please note that the underlying revenue forecasts are typically updated three times each year: in preparation for the LongRange Financial Outlook, the Governor’s budget recommendations, and the General Appropriations Act enacted by the Legislature. All estimates and projections used in this Handbook are based on a series of estimating conferences held in July and August of 2024. 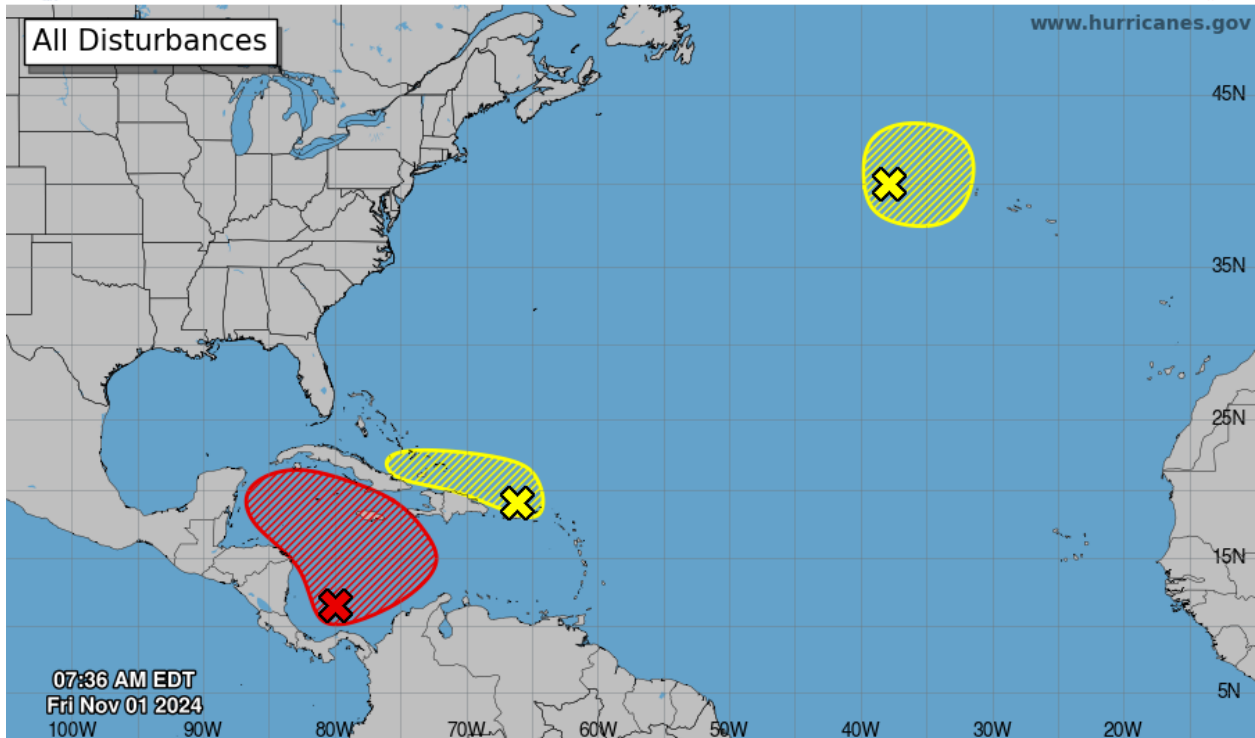
