In 81 days, Tuesday, March 4th, the Florida Legislature will convene the 2025 Regular Session of the Florida Legislature. New leadership in the Senate and the House will guide the respective legislative bodies for the next two years.

- Ben Albritton, will lead the Senate. Senator Albritton is a legislator that is "Rural" through and through! He served in the House leading on many issues impact small counties and rural areas. His opening remarks outline his aspirations and priorities. One of the Presidents major priorities will be what he is calling a "Rural Renaissance!" We look forward to working with the Senator's Office in supporting those issues of highest significance roads, education, agriculture, economic development, water and more!
- Danny Perez, will lead the House. Representative Perez is a smart, affable person. He is married and has a small children. He is of Cuban decent and the historical perspective of what happened in the 50's and 60's has been foundational in his thinking. Perez has expressed an intention to reduce the size of the budget which signals the importance of

documenting all requests with clear plans and information justifying R.O.I. He is fair and accessible – it will be a pleasure working with his staff this session.

Over the next few weeks there will be hundreds of bills filed in the House and the Senate. Not all will be heard – very few will pass the both the House and Senate. We will begin tracking bills by topic – education, local government, etc.

Small County Rural Legislators Will Be Influential and Effective

There are 12 Senate and 21 House Districts that include all or a portion of a small county. These legislators are aware and engaged on issues impacting our counties and school districts. Now is the time to work closely with your local house and senate members. Prepare a legislative program and reach-out to your legislators to review your priorities. Local budget request guidelines are open in the House and will open soon in the Senate.
