Tucker Civic Center, 505 West Pensacola St., Tallahassee. • JUSTICES HEAR FIREFIGHTER CASE - Monday, 10 a.m. The U.S. Supreme Court will hear arguments in two cases, including a dispute about whether the city of Sanford violated the Americans with Disabilities Act by limiting a health-insurance subsidy for a firefighter who retired early because of Parkinson's disease. The lawsuit was filed by Karyn Stanley, a fire-department lieutenant who retired in 2018 at age 47 because of the effects of Parkinson's disease. The dispute stems from Stanley losing a health-insurance subsidy two years after she retired. She took the case to the Supreme Court after the 11th U.S. Circuit Court of Appeals ruled she could not sue under part of the Americans with Disabilities Act. U.S. Supreme Court, Washington, D.C.
