What's Going On?

House Committee to discuss Home Rule and Preemption of Local Governments Link to Live Stream Schedule of Meeting

The House Intergovernmental Affairs Subcommittee will meet Wednesday at 1:00pm in 17 HOB - Morris Hall of the House Office Building. On the agenda: An Overview of county and municipal home rule powers and preemption of local governments and a panel discussion of such home rule powers and preemption of local governments. Preemptions and Unfunded Mandates are two of the significant areas where local governments authority is restricted/diminished and costs are increased through state requirements. Tune in – it will be instructive as to how the legislature will respond to the panel. The panel included FAC Executive Director Ginger Delegal.

Legislative leaders balk at DeSantis' call for a special session.

Memo calls Special Session before the Regular Session - "premature" and "irresponsible".

In a joint memorandum to all State Legislators, Senate President Ben Albritton and House Speaker Danny Perez responded to the Governor's call for a Special Session. The memo was very direct – leaving no question about the position of the legislative leadership. Here are some quotes for the memo –

- "Calling a special session at this time is premature."
- "It is **completely irresponsible** to get out ahead of any announcements President Trump will make, especially when uninformed or ill-timed state action could potentially impair or impede the success of President Trump's forthcoming efforts to end illegal immigration, close our borders, and protect the sovereignty of our nation."
- "Florida's Constitution compels our attendance at a special session unilaterally called by the Governor. However, the power to convene a special session also resides with the presiding

officers. As the people's elected representatives, the Legislature, not the Governor, will decide when and what legislation we consider."

School Start Time Survey Responses 36 Small Districts were surveyed on Monday – 23 have responded Middle School and High School Start Times

<u>Text of Legislation as passed.</u> <u>Staff Analysis of Start Time Legislation</u> Initial Responses

- 23 of the 36 districts surveyed responded within 24 hours.
- 9 of the 23 respondents currently meet the Start Time Requirement
- 14 of the 23 respondents do not currently meet the Start Time Requirement
- All 23 respondents indicated a preference that the statutes provide for flexibility from the specific start times.
- 8 of the 9 districts meeting requirements start Elementary schools earlier than Middle and High Schools.
- The 14 districts that have not yet implemented the required start times, start high schools and middle schools earlier than the district elementary schools.
- Additional comments outlined challenges and issues including staffing; transportation; supervision; impact on parent drop-off conflicting with work schedules; extra-curricular activities and after-school events are started later; and, later release times impact students ability to supervise siblings and cut into work schedules.
