Appropriations Budget Proposals Ready for Floor Action in Week Seven

House and Senate Face Budget proposals are about \$4.4 billion apart.

Last years budget totaled \$117.46 billion.

The Senate Proposed budget comes in at \$117.36 billion.

The House proposal totals \$112.95 billion.

The House Budget Committee and the Senate Appropriations Committee approved the proposals Wednesday, positioning them up to go to the full House and Senate next week. Both House and Senate Appropriations Chairs are trying to "right size" state spending after passing record budgets in previous years. Differences are centered around pay raises for state employees, tax cuts and whether to back away from spending for the Florida Wildlife Corridor and Live Local.

A main difference involves spending on state employees -

- Reducing Positions The Senate proposal does away with about 1,000 full-time positions that have been vacant at state agencies for at least 100 days. The House eliminate about 7,000 positions that have been vacant 90 days or longer.
- Pay Raises The Senate has proposed 4 percent pay increases for state employees, while the House has not proposed such pay hikes.

Different Approaches on Tax Reduction –

• The House proposes to cut the state's sales-tax rate from 6 percent to 5.25 percent reducing revenue by about \$5 billion. Senate President Albritton has suggested taking more time to study the sales-tax proposal and the Governor's Proposal to cut property taxes.

Changing Direction on Previously Approved Programs

- The House is proposing to repeal a 2024 law that earmarked \$834 million from a gambling deal with the Seminole Tribe of Florida used in 24-25 to expand the state wildlife corridor and other environmental projects. The proceeds would be transferred to the state's general-revenue fund.
- The House is also proposing to eliminate the recurring earmark of \$150 million a year in documentary-stamp taxes for certain affordable-housing efforts. The money funded the "Live Local Act," a priority of former Senate President Kathleen Passidomo, R-Naples.

Differences also exist in FEFP Funding- the Governor's Budget Proposal is the most favorable but its

Program Weights / Comparable Wage Factor/ Small District Factor

- HB 5101 Education does a number of things but one of the more significant changes is the reduction by ½ of the weight for each of the programs with a program cost factor. This will have a significant impact on high-cost programs including CTE and Career Path programs. The Senate does not have this provision.
- Senate Education Budget Maintains the Comparable Wage Factor with a base of 1.0. The House does not compress the CWF to 1.0.
- Small District Factor in the FEFP The Senate increases the Small District Factor to 1.0554. The House uses 1.0403 for the Small District Factor

On to Floor Consideration then to Conference

The Proposals below are now referred to the full House and Senate for approval. Once the proposals are approved by their respective chambers – the budget process will move into the "Conference Process" where members from the House and Senate will meet to iron out the differences. SB 2502 Implementing the 2025-2026 General Appropriations Act by Appropriations

Implementing the 2025-2026 General Appropriations Act; Authorizing the Agency for Health Care Administration, in consultation with the Department of Health, to submit a budget amendment to realign funding for specified purposes; extending for 1 fiscal year the exemption of certain rules pertaining to the medical use of marijuana from certain rulemaking requirements; revising the Quality Incentive Program payment pool percentage for the reimbursement of Medicaid providers; requiring the Department of Children and Families to develop and report on an alternative tiered funding methodology and to provide certain information, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2025, or, if this act fails to become a law until after that date, it shall take effect upon becoming a law and shall operate retroactively to July 1, 2025
