#### School Start Time Repealed

This afternoon SB 296 repealing the School Start Time Mandate passed the House floor!

## The vote on the House floor was unanimous. Analysis of New School Start Time Legislation - Repeals Mandated Start times!

# No agreement yet on Tax Plan – However Speaker Perez announced the creation of a Select Committee on Property Tax. This may clear the way for moving forward on tax plan.

The committee will be tasked with reviewing the current state of property taxes in Florida and exploring proposals to reduce the financial burden on homeowners. The Select Committee on Property Taxes is expected to hold its first meeting on Thursday, May 1st. The Select Committee will begin its work by exploring a variety of potential reforms, including:

- Requiring every city, county, and special district to hold a referendum on the question of eliminating property taxes on homestead properties.
- Creating a new \$500,000 homestead exemption, as well as a \$1 million homestead exemption for properties owned by Floridians aged 65 and older, or who have had a homestead for 30 years, applicable to all non-school taxes.
- Authorizing the Legislature to increase the homestead exemption to any value by general law. Modifying the assessment increase limitations on property values:
  - o For homestead properties, changing the cap from the lower of 3% or CPI to a flat 3% over any three-year period for all taxes.
  - For non-homestead properties, changing the cap from 10% annually to 15% over any three-year period for all non-school taxes.
- Protecting Homeownership by eliminating the ability to foreclose on a homestead property due to a property tax lien.
