So Where are We? What's gonna happen

With five days left that are big differences divide the House and Senate.

Things appear stalled but its probably more likely slowing down!

We shall see what happens in the Senate tomorrow and the House on Tuesday.

What will happen if they don't finish on time?

Uncertain as to Special Session or Extended Session.

If Session adjourns – bills that have not passed both the House and Senate will die! There are some very unfriendly bills that include rural priorities and other changes likely abolishing TDC's and CRA's.

Most of this legislation can come back next year with more study and understanding.

Here's what we do know -

Theres no budget if there is no agreement on tax reductions
Without an agreement on the revenue – the budget process can not move forward.

It is unlikely, however, not impossible to finish on time. Not sure if they will extend the session keeping legislation alive or end the session and come back in a special session to take up the budget. If they adjourn – bills will die! There are a lot of bad bills in Senate Messages from the House that it would be good if they just went away! There are also some bills – like the School Start Time bill that could fall victim to the situation. Hopefully, we can get HB 261 taken up in the House and then pass the Senate Version which is in messages from the Senate.

Theres no budget if there is no agreement on tax reductions -

- The House wants a recurring reduction of .75 of 1 cent.
- The Senate does not support a recurring reduction but will support a targeted reduction of sales tax on a non-recuring.

What's the difference -

- The House proposal to cut the sales tax has severe consequences in the out years.
 - The House proposal has immediate negative impacts on recurring GR in the first two fiscal years 2025-2026 and 2026-27.
 - For this upcoming year and next, the House proposes to backfill the loss of recurring GR with non-recurring funds.
 - But by the third fiscal year 2027-28 the State's nonrecurring funds will be depleted causing the Legislature to drastically cut its recurring budget or raise taxes to fill the hole or both.
- The Senate President does not want to jeopardize future year funding based on Sales Taxes.

Without an agreement on the revenue – the budget process cannot move forward.

The revenue plan adopted will set the allocations for the appropriations process to move forward. The House and Senate have been reviewing side by side budget proposals which will give them a head-start on the budget process. The conference process could move quickly when the tax decisions are resolved.

- The current year budget is \$117.5 billion
- The Senate Proposal is \$117.4 billion
- The House Proposal is \$112.9 billion
- The Governor's budget recommends \$115.6 billion for fiscal year 2025-26.

What are some of the Issues in Play -

- Rural Renaissance Proposal the Senate's Rural Renaissance package has passed the Senate and sent to the House. The House split the package into three pieces and put them into three House Bills. All three bills have been passed by the House and are in Senate Messages. Funding has been stripped and will be an appropriation issue. Here is a staff analysis for each bill.
 - o HB 991 now amended onto SB 110 and returned. Its totally different that SB 110. <u>Staff Analysis of HB 991 now SB 110 passed by the House and is in Senate Messages.</u> The bill effectively dissolves CRA's over time.
 - HB 1427 Health Care includes the health care components of the RR along with other controversial issues that House supports. <u>Analysis of HB 1427 - passed by the</u> <u>House and in Senate messages</u>
 - HB 1267 House Education bill includes education components of the RR program. Staff Analysis of HB 1267 Education Train

<u>Repeal of School Start Time</u> - HB 261 is on 2nd reading but not on Special Order – SB 296 has passed the Senate and is in the House. All that has to happen is the House take up SB 296 and the mandated start time statutes will be repealed.

<u>FEFP funding</u> – The Senate budget proposal is better than House, the Governor's proposal is better and does not adjust the weights. Problem- Gov's proposal is not in play Here are the proposals - `

- The House Proposal for the FEFP
- The Senate Proposed FEFP
- The Governor's Proposed funding for the FEFP
 - o Program Cost Factors Weighted FTE's Both the House and Senate have agreed to reduce weighted cost factors by 50%. Both have indicated that the funding related to the 50% will be transferred into the Base Student Allocation to provide flexibility to the districts. That's an interesting look, however, it creates a budgeting problem at the district level in terms of maintaining previous funding levels for the weighted programs.

<u>Special Facilities</u> – the Senate and House have taken different approaches to funding special facilities funding. Here's where things stand - <u>Special Facilities Recommendations and House-Senate Recommendations .docx</u>

HB 7033 - Repeal of TDC, Transfer of TDT funds to county for property tax reduction and a Repeal of the Opt Out provision in the Live Local Act - Staff Analysis of HB 7033.

The bill has passed the House and is in Senate messages. This is a major part of the problem in getting agreement on the tax package.

HB1221 –Impacts local option sales taxes and repeals the TDC provisions – as in HB 7033. Staff Analysis of HB 1221 - Local Option Sales Tax

<u>Changes to Sovereign Immunity</u> – Proposals are tied up – appear in critical condition – likely dead.

<u>Term Limits</u> – House proposal passed the House and is in messages in the Senate. The Senate has indicated that they will not take the bill up. So – DEAD!
