The Florida House and Senate in the coming week will continue to pass major bills before the scheduled May 2 end of the legislative session. In addition to such policy issues, the House and Senate have proposed budgets that are more than \$4 billion apart. As of Friday, it remained to be seen when they would start formal negotiations on a budget for the fiscal year that will start July

# <u>Regional Planning Councils Repeal Tabled -</u>

#### SB1264 tabled in Rules Committee -

In a surprise announcement – SB 1264 was temporarily passed and did not take up in the Senate Rules Committee. The bill which repealed statutory reference to RPC's appears "dead" in legislative terminology. The Small County Coalition has been requesting that the RPC repeal be removed from the bill.
