***Governor DeSantis To Sign Budget Today***

After being presented the budget, SB 2500 Friday afternoon, Governor DeSantis is expected to sign it today. Detailed information, including vetoed funding, will be provided as it is released.

- The Fiscal Year 2025-26 budget totals \$115.1 billion (\$50.6 billion General Revenue, \$28.2 billion State Trust Funds, and \$36.3 billion Federal Trust Funds) and includes funding for 111,885 authorized positions.
- The budget is composed of 68.5% state funds and 31.5% federal funds. The budget is a decrease of \$3.8 billion (3.2%) from the current year budget, and includes a net reduction of 1,956 positions (1.7% decrease).

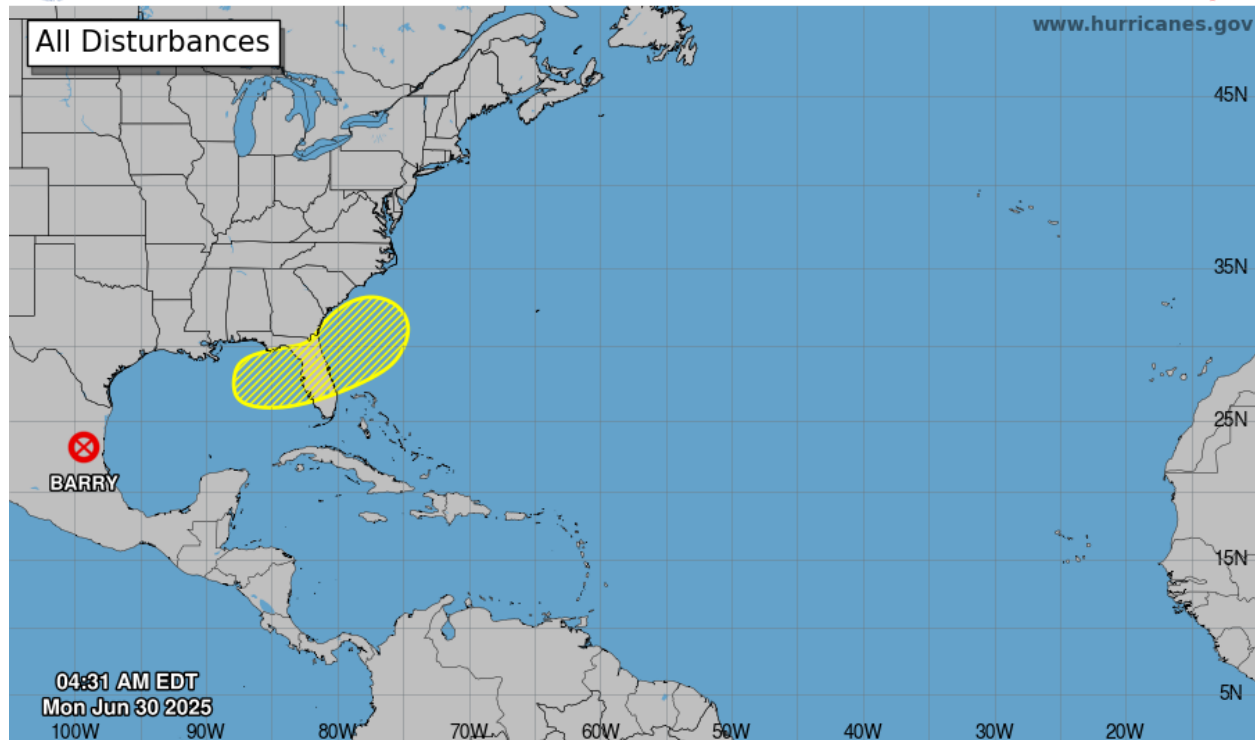
