The 2025 Legislative Session

The dynamics of the Legislative Session can be characterized as Unprecedented; Acrimonious, Significant, and Difficult. After 45 additional days the session ended with the adoption of the General Appropriations Act and Tax Package.

Appropriations

SB 2500 has not yet been submitted to the Governor!

After 45 extra days – the legislature reached agreement on a budget.

- Generally – the Small County Appropriation Items sustained with status quo or slight increases.
- Significant funding was allocated for local projects.

Florida TaxWatch identifies \$416 million in ‘Budget Turkeys’ for FY 2025-26

Florida TaxWatch identified 242 projects totaling \$416.1 million that it believes Gov. Ron DeSantis should veto. Tax Watch identified \$800 million in additional projects that “merit extra scrutiny.”

Legislative Actions

Term limit proposals died.

Sovereign Immunity Increase Caps died.

Elimination of Regional Planning Councils died.

Transfer of TDC funding to BOCC’s for property tax reduction died.

Elimination of the Opt Out provision of Property Tax Exemption in the Affordable Housing legislation died.

Significant Actions

- Amended legislation that would have required counties to pay for right of way relocation cost of Broadband/ISP facilities.
- Pushed concerns regarding Solar Fields above the radar and creating some legislative concern.

Disappointment –

Rural Renaissance not moving through the House.

Elimination of Business Rental Tax will impact local revenue.

Statewide WebEOC Initiative not funded will result in counties getting a minimum of \$50K hit.

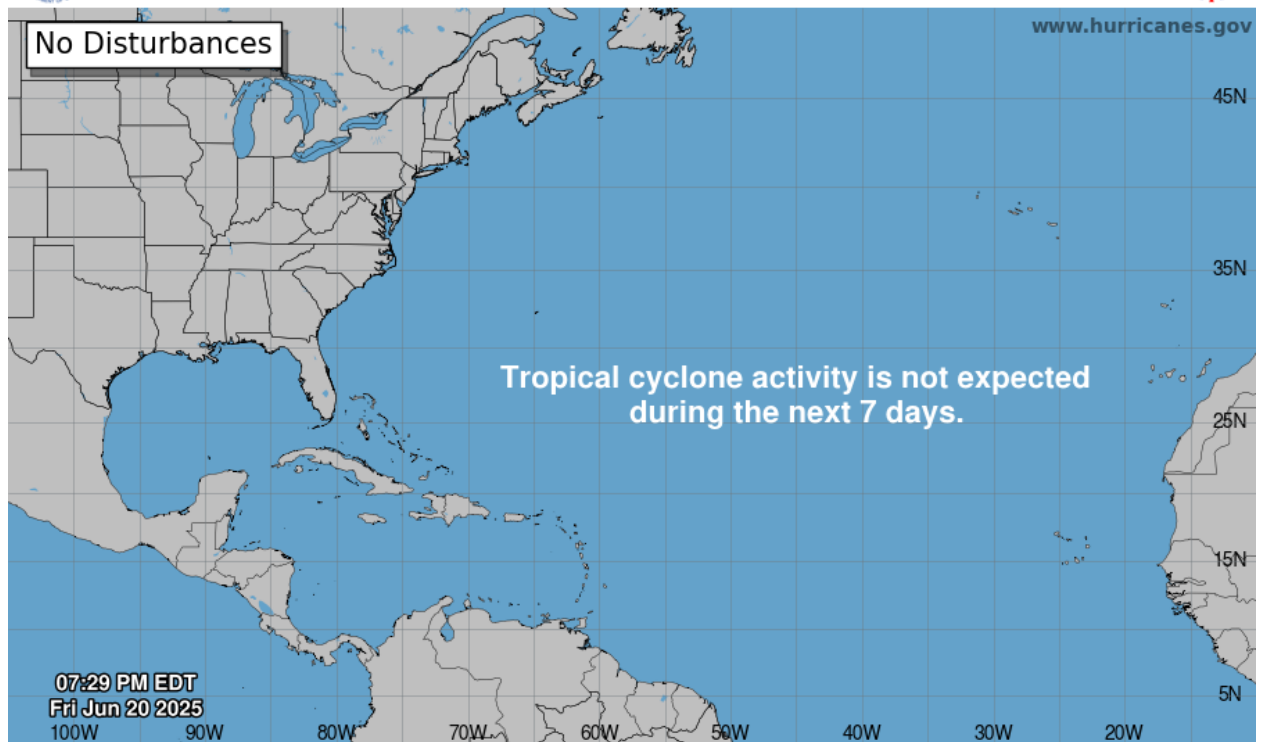
