## Introduction

**The Regular Session ended Friday, March 13 when the Senate and House adjourned the 60 day session.**

The Legislative Session adjourned without approving a Budget for the 25-26 Fiscal Year or the Property Tax Proposals .

What's Next? Bills will be sent to the governor The remaining business will be taken up in a Special Session to convene the week following Easter – week beginning the 6<sup>th</sup>.

### *INITIAL RESULTS FROM THE SESSION*

**25-26 General Appropriations Act** – To Be Considered in Extended Session  
**Tax Legislation** – revenues for FY25-26 – To Be Considered in Extended Session  
**Property Tax Proposals** – Undecided – no agreement.

**Term Limits** – Bill was filed but never heard!

**Sovereign Immunity Changes** – Did Pass – Caps were increased - See SB 145

**Implementing Bills to Offset impact of TPP Ag. Exemption** – Did Not Pass

**Rural Renaissance** did not pass but provisions are proposed in the Senate budget and Tax Bill.

**Blue Ribbon Development Proposals** – Did Not Pass

**Biosolids Several** Bills Passed

**School Board Bill Of Rights** – See SB 1620 - Note: There were no changes to employment of relatives. Bill also requires all board members to receive information requesting by one board member.

**School Voucher Transparency and Accountability Bill** – SB 318 did not pass!

## 2026 - Bills that passed dealing with Education

### Ordered by Bill Number

- SB 0178**    **Athletics in Public K-12 Schools** by Jones  
Athletics in Public K-12 Schools; Requiring the Florida High School Athletic Association to adopt bylaws authorizing a head coach to support the welfare of a student by using personal funds to provide certain effects to the student; requiring the head coach to report such use of personal funds to the association; providing that such use of personal funds is presumed not to be an impermissible benefit, etc. Effective Date: 7/1/2026
- HB 0453**    **Requirements for a Standard High School Diploma** by Gossett-Seidman  
Requirements for a Standard High School Diploma: Provides that completion of 2 years of marching band satisfies both physical education & performing arts requirements for standard high school diploma & that students with disabilities may participate in Special Olympics to meet physical education requirement for standard high school diploma. Effective Date: July 1, 2026
- SB 0538**    **Extracurricular Activities** by Simon  
Extracurricular Activities; Authorizing district school boards to adopt policies for the use of certain funds to provide funding to athletic coaches or activity sponsors of extracurricular activities; revising eligibility requirements for a student to participate in an interscholastic or intrascholastic extracurricular activity; deleting requirements for the Florida High School Athletic Association (FHSAA) to facilitate a program for private school students to participate in an interscholastic or intrascholastic sport; authorizing a public school to assess an activity fee for certain students, etc. Effective Date: 7/1/2026
- HB 0561**    **Educator Preparation and Certification** by Gerwig  
Educator Preparation and Certification: Revises provisions relating to educator preparation institutes, award of temporary educator certifications, & reinstatement & renewal of professional educator certificates; & revises requirements for Florida Center for Teaching Excellence. Effective Date: July 1, 2026
- HB 0753**    **School Counselors** by Hunschofsky  
School Counselors: Requires evaluation criteria for certified school counselors to be based on specified standards; provides that persons seeking employment as school counselors are exempt from specified educator certification requirements; & provides that school districts may require such persons to meet certain requirements as condition of employment. Effective Date: July 1, 2026
- HB 0757**    **School Safety** by Salzman  
School Safety: Requires sheriffs to assist public postsecondary educational institutions in implementing guardian programs under certain provisions; authorizes public postsecondary educational institutions to participate in the school guardian program; requires a sheriff to establish a guardian training program or contract with certain other sheriff's offices to do so in certain circumstances; creates the offense of discharging a weapon or firearm within 1,000 feet of a school, etc. Effective Date: upon becoming a law
- SB 0824**    **School District Unimproved Real Property** by Truenow

School District Unimproved Real Property; Requiring school districts to annually submit complete inventories of unimproved real property owned by the district to the Department of Education; requiring the department to compile and publish such data in a statewide report, etc. Effective Date: 7/1/2026

**HB 0851** **Professional Learning for Instructional and School Administrative Personnel** by Long  
Professional Learning for Instructional and School Administrative Personnel: Requires certain professional learning systems to provide at least one autism-specific professional learning opportunity. Effective Date: July 1, 2026

**HB 1073** **School Districts** by Koster  
School Districts: Provides members of district school board with specified rights relating to school district documents & budget matters; requires that certain documents from district school board meetings be kept as public records; requires that full line-item budget items be posted on school district's website; requires district school boards to adopt policy prohibiting requirement that district employees be required or incentivized to sign nondisclosure agreement or confidentiality agreement. Effective Date: July 1, 2026

**HB 1115** **Grants for Genetic Counseling Education** by Anderson  
Grants for Genetic Counseling Education: Creates Genetic Counseling Education Enhancement Grant Program within State University System; provides requirements for program. Effective Date: July 1, 2026

**HB 1201** **Student Health and Safety** by Mooney Jr.  
Student Health and Safety: Revises DOH responsibilities for educational programs concerning epilepsy; revises requirements for student's individualized seizure action plan; revises list of which employees must complete training in care of students with epilepsy & seizure disorders; & provides that training is valid for 5 years. Effective Date: July 1, 2026

**HB 1279** **Education** by Kincart Jonsson  
Education: Revises provisions relating to vocational rehabilitation services, dual enrollment, FCS institutions, state universities, & career centers. Effective Date: July 1, 2026

**HB 4027** **Hillsborough County Public Schools, Hillsborough County** by Owen  
Hillsborough County Public Schools, Hillsborough County: Provides for elected superintendent of schools; requires referendum. Effective Date: upon becoming a law, except that section 2 shall take effect only upon approval by a majority vote of those qualified electors of Hillsborough County voting in a referendum to be held in conjunction with the 2026 general election

<a href="#"><u>HB 0033</u></a>	<b>Transportation Facility Designations</b> by Porras Transportation Facility Designations: Provides honorary designations of certain transportation facilities in specified counties; directs DOT to erect suitable markers. Effective Date: July 1, 2026
<a href="#"><u>HB 0035</u></a>	<b>Habitual Traffic Offender Designation</b> by Barnaby Habitual Traffic Offender Designation: Revises definition of term "habitual traffic offender." Effective Date: July 1, 2026
<a href="#"><u>HB 0091</u></a>	<b>Candidate Qualification</b> by Tant Candidate Qualification: Specifying that a person seeking to qualify for office as a candidate must be a registered member of a political party, or registered without any party affiliation, for 365 consecutive days preceding the beginning of qualifying for an election; specifying that such person may not have legally changed his or her name through a specified petition during such 365-day period; providing that compliance with specified requirements is mandatory; providing construction; authorizing qualified candidates or certain political parties to challenge compliance with specified provisions by filing suit in a specified circuit court; prohibiting a person from being qualified as a candidate for nomination or election and appearing on the ballot under specified circumstances. Effective Date: upon becoming a law
<a href="#"><u>SB 0118</u></a>	<b>Assessments Levied on Recreational Vehicle Parks</b> by Truenow Assessments Levied on Recreational Vehicle Parks; Prohibiting counties, municipalities, and special districts, respectively, from levying certain special assessments against more than a specified square footage amount per recreational vehicle parking space or campsite, etc. Effective Date: Upon becoming a law
<a href="#"><u>HB 0131</u></a>	<b>Curators of Estates</b> by Maggard Curators of Estates: Revises requirements for court to appoint curator of estates; revising bond requirements for curators; clarifies who may subject a curator to removal & surcharge; requires curator to file periodic reports with court in specified circumstances; requires that certain details be included in such reports; requires court to review such reports; authorizes court to require more frequent reporting or additional documents. Effective Date: July 1, 2026
<a href="#"><u>HB 0145</u></a>	<b>Claims Against the Government</b> by McFarland Claims Against the Government: Increasing the statutory limits on the liability of the state and its agencies and subdivisions for tort claims; revising exceptions relating to instituting actions on tort claims against the state or one of its agencies or subdivisions; revising the period after which the failure of certain entities to make a final disposition of a claim shall be deemed a final denial of the claim for certain purposes; revising the statute of limitations for tort claims against the state or one of its agencies or subdivisions and exceptions thereto, etc. Effective Date: October 1, 2026
<a href="#"><u>HB 0167</u></a>	<b>Former Phosphate Mining Lands</b> by McClure Former Phosphate Mining Lands: Provides conditions for cause of action against certain former phosphate mine sites; authorizes landowners to record certain notice of former phosphate mines; specifies requirements for such notice; requires DOH to conduct gamma radiation surveys of former phosphate land parcels upon petition; requires that specified documentation of radiation levels be submitted in certain civil actions related to phosphate mining. Effective Date: July 1, 2026
<a href="#"><u>HB 0177</u></a>	<b>Offices of Criminal Conflict and Civil Regional Counsel</b> by Maney

Offices of Criminal Conflict and Civil Regional Counsel: Requires offices of criminal conflict & civil regional counsel to provide notice to court in certain circumstances; authorizes courts to appoint office of criminal conflict & civil regional counsel from another region to represent defendant if certain requirements are met; requires court to appoint private counsel; requires JAC to pay appointed office of criminal conflict & civil regional counsel for due process costs & services, subject to legislative appropriation; requires appointed counsel to provide certain documentation to JAC in order to receive payment or reimbursement. Effective Date: July 1, 2026

**HB 0199**     **Veterans Affairs** by Maney

Veterans Affairs: Revises admissions process for veterans treatment court programs; authorizes court, in consultation with multidisciplinary team, to determine eligibility for veterans treatment court programs; requires court to consider recommendation of state attorney when making eligibility determination; authorizes sentencing courts to divert defendants to veterans treatment court programs; requires certain notice be provided to defendants; provides for disposition of probation or community control violations by program participants. Effective Date: July 1, 2026

**HB 0245**     **Child Pornography Terminology** by Baker

Child Pornography Terminology: Replaces the term "child pornography" with the term "child sexual abuse material"; provides legislative intent and applicability, etc. Effective Date: July 1, 2026

**SB 0246**     **Specialty License Plates** by Gruters

Specialty License Plates; Increasing the annual use fee for the Florida Wildflower license plate and providing a discount for owners purchasing the plate for more than a specified number of vehicles; deleting a restriction on who may be issued the Fraternal Order of Police license plate; directing the Department of Highway Safety and Motor Vehicles to develop specified specialty license plates, etc. Effective Date: 10/1/2026

**HB 0249**     **Designation of Official State Flagship** by Gonzalez Pittman

Designation of Official State Flagship: Redesignates official state flagship as S.S. American Victory. Effective Date: July 1, 2026

**HB 0271**     **Foreign and Alien Bail Bond Insurers** by Valdés

Foreign and Alien Bail Bond Insurers: Provides duties of certain foreign & alien bail bond insurers relating to reporting bail bond premiums to OIR, keeping records of considerations paid for bail bonds written by insurers, & disclosing certain information in financial statements filed with office. Effective Date: July 1, 2026

**HB 0273**     **Special District Funding** by Johnson

Special District Funding: Revising agency agreements that provide state financial assistance to recipients or subrecipients to include specified special districts as an entity to which such agency may provide for the payment of invoices under specified circumstances; providing construction; requiring state agencies to expedite payment requests from certain counties, municipalities, and special districts for a specified purpose, etc. Effective Date: July 1, 2026

**HB 0277**     **Domestic Violence and Protective Injunctions** by Tendrich

Domestic Violence and Protective Injunctions: Reclassifying penalties for committing a domestic violence offense if a person has a prior conviction for domestic violence; providing that sentencing and incentive gain-time eligibility determinations are made without regard to a penalty enhancement; establishing an electronic monitoring pilot program in a specified county; requiring the sheriff, in consultation with certain persons, to design and implement the pilot program; providing requirements for the pilot program; requiring the Department of Corrections to complete an evaluation and provide specified reports to the Legislature; requiring the Department of Law

Enforcement to enter injunctions against dating violence and sexual violence into a statewide verification system, etc. Effective Date: July 1, 2026

**SB 0288**     **Rural Electric Cooperatives** by Rodriguez

Rural Electric Cooperatives; Prohibiting a cooperative that sells electricity at retail from adopting, enacting, or enforcing a fee meeting specified criteria; revising the applicability of such prohibition on the types or fuel sources of energy production which may be used, delivered, converted, or supplied by specified entities, etc. Effective Date: 7/1/2026

**SB 0290**     **Department of Agriculture and Consumer Services** by Truenow

Department of Agriculture and Consumer Services; Prohibiting counties from enacting or enforcing any law that restricts or prohibits the use of gasoline-powered farm equipment or gasoline-powered landscape equipment or that distinguishes such equipment from any other equipment under certain circumstances; prohibiting an application for a development on an ecologically significant parcel in a low-density municipality from being administratively approved without an attestation provided by the developer; establishing the Florida Food Animal Veterinary Medicine Loan Repayment Program; revising the Florida Forest Service's powers, authority, and duties, etc. Effective Date: 7/1/2026

**HB 0325**     **Education and Workforce Development for Inmates** by Kendall

Education and Workforce Development for Inmates: Authorizes DOT to expend certain funds for all workforce development programs, rather than only construction workforce development programs; authorizes department to provide grants to private educational providers to use for certain certification & training opportunities; requires certification & training opportunities to include training for specified commercial driver licenses to certain inmates; provides eligibility; authorizes department to use workforce development funds for certain certification & training opportunities; requires Correctional Education Program under DOC to annually submit report to Secretary of Corrections with specified information; authorizes Correctional Education Program to implement career & technical education program in which certain inmates can earn specified commercial driver licenses; provides eligibility; authorizes inmate to be transported in or to operate state-owned vehicle; requires certified correctional officer to be present during such transport or operation. Effective Date: July 1, 2026

**HB 0359**     **Search Warrants** by Anderson

Search Warrants: Authorizes search warrant to be issued to recover deceased body; revises time within which certain search warrants must be returned to court; specifies time period within which search warrant issued for certain devices is considered timely executed; specifies that law enforcement agency may review data or information contained in certain devices after specified periods if devices were timely seized; provides that judge may authorize law enforcement officer applying for search warrant to appear remotely; provides that judge may authorize law enforcement officer applying for search warrant or court order to appear remotely; defines "audio-video communication technology"; authorizes law enforcement agency to obtain search warrant to use drone to conduct search in certain circumstances. Effective Date: July 1, 2026

**HB 0397**     **Violations of Pretrial Release Conditions for Violent Crimes** by Daley

Violations of Pretrial Release Conditions for Violent Crimes: Provides that person who is on pretrial release for specified violent crime commits separate criminal offense if such person willfully violates certain conditions of pretrial release; provides penalty for second or subsequent violation; requires person who is arrested for committing specified violations to be held in custody until his or her first appearance hearing; requires court to consider certain factors in determining whether to order pretrial detention or grant pretrial release; provides that law enforcement officer is not liable in civil action for arrest of person based on probable cause to believe that person has violated condition of pretrial release in specified circumstances; authorizes law enforcement officer to arrest person

without warrant if there is probable cause to believe that person has willfully violated certain conditions of pretrial release. Effective Date: October 1, 2026

**HB 0399**     **Land Use and Development Regulations** by Borrero

Land Use and Development Regulations: Requires amount of application fees associated with development permits or orders to reasonably relate to certain costs; requires public schools interlocal agreements to address reasonable access to certain public easements & public rights-of-way; requires local governments to administratively approve applications for minor special exceptions or variances submitted by large destination resorts; requires local government comprehensive plans & land development regulations to include factors for assessing compatibility of certain residential uses; requires land development regulations to incorporate measures for mitigating or minimizing potential incompatibility; prohibits residential manufactured buildings from being denied a building permit for placement on certain lots; requires housing units located on a mobile home lot to be taxed in a specified manner and be subject to payments to a specified fund; requires off-site constructed residential dwellings to be permitted as of right in certain zoning districts; requires OPPAGA to conduct specified study; requires office to submit results of study to Legislature by specified date. Effective Date: upon becoming a law

**SB 0418**     **Law Enforcement Officer Interactions with Individuals with Autism Spectrum Disorder** by Jones

Law Enforcement Officer Interactions with Individuals with Autism Spectrum Disorder; Requiring the Department of Highway Safety and Motor Vehicles to establish a program to improve communication between individuals with autism spectrum disorder and law enforcement officers under certain circumstances; requiring the department to develop and make available to individuals with autism spectrum disorder a certain envelope and card by a specified date; defining the terms "agency" and "autism spectrum disorder"; requiring the Criminal Justice Standards and Training Commission within the Department of Law Enforcement to establish an employment training component relating to individuals with autism spectrum disorder, etc. Effective Date: 7/1/2026

**HB 0425**     **Historic Cemeteries Program** by Aristide

**HB 0991**      **Election Integrity** by Persons-Mulicka

Election Integrity: Revising definitions; revising the information the Department of State is required to include in a specified report; requiring persons to swear or affirm they have reviewed the voter registration instructions, are a United States citizen, and understand the penalties for providing false information; requiring the voter registration application to elicit documentation required by the United States Election Assistance Commission or federal law; requiring that an applicant's citizenship status be verified by the records of the DHSMV; providing that an applicant will be registered as an unverified voter, and must vote with a provisional ballot that will not be counted if his or her legal status as a United States citizen cannot be verified through the DHSMV; requiring the online voter registration system to transmit certain information to the supervisor of elections and generate certain notices; requiring the supervisor of elections to verify the legal status of certain applicants and provide certain notice; providing that, under specified circumstances, the online voter registration system may populate the applicant's information into a printable voter registration application; requiring an applicant's legal status to be verified for a voter registration application to be valid; providing that an applicant will be deemed an unverified voter if his or her application fails to meet specified requirements. **HB 1019**      **Perfluoroalkyl and Polyfluoroalkyl Substances** by Conerly

Perfluoroalkyl and Polyfluoroalkyl Substances: Prohibits, beginning on specified date, certain use & sale, purchase, or distribution of aqueous film-forming foam; requires, beginning on specified date, certain entities to submit aqueous film-forming foam inventories & disposal plans to DEP; prohibits, beginning on specified date, possession & use of aqueous film-forming foam; authorizes DEP to administer certain grants or cost share programs; provides penalties & injunctive relief; requires certain public entities disposing of domestic wastewater biosolids and treated effluent to quarterly conduct specified samplings & submit results to DEP; limits purpose such samplings until specified standards are established by EPA & adopted by DEP. Effective Date: July 1, 2026

**HB 1031**      **Customer Service Callback Queues** by Rosenwald

**HB 1069**      **Background Screenings** by Trabulsy

Background Screenings: Revises definition of term "athletic coach"; provides that independent sanctioning authority is deemed to be qualified entity for purpose of participating in Care Provider Background Screening Clearinghouse; requires qualified entities to designate user administrator for specified purpose; prohibits certain persons from denying or failing to acknowledge certain criminal history records that have been expunged or sealed; requires FDLE to disclose sealed criminal history records. **HB 1081**     **Cybersecurity Experiential Learning** by Sirosis

Effective Date: July 1, 2026

**HB 1085**     **Local Government Cyber Security** by Miller

Local Government Cyber Security: Creates Local Government Cybersecurity Protection Program within University of South Florida, to be administered by Florida Center for Cybersecurity; requires Florida Center for Cybersecurity to enter into data-sharing agreements with local governments & Florida Digital Service; requires Florida Center for Cybersecurity to administer grant program based on specified criteria to provide information technology commodities & services to local governments; requires Florida Center for Cybersecurity to contract for information technology commodities & services & award such commodities & services to local governments; requires Florida Center for Cybersecurity to prepare & submit specified report to Governor's Office of Policy & Budget & chairs of legislative appropriations committees. Effective Date: July 1, 2026

**HB 1087**     **Pub. Rec./Office of Financial Regulation** by Grow

Pub. Rec./Office of Financial Regulation: Expanding a public records exemption for certain information obtained by the Office of Financial Regulation concerning or during the course of an investigation or examination conducted by the office, including customer and consumer complaints, to incorporate the inclusion of documents relating to virtual currency businesses, qualified payment stablecoin issuers, and money transmitters acting as custodians of gold coin and silver coin; providing for future legislative review and repeal of the exemptions, etc. Effective Date: on the same date that HB 175 or similar legislation takes effect

**HB 1103**     **Local Administration of Vessel Restrictions** by Andrade

Local Administration of Vessel Restrictions: Authorizes counties & municipalities to adopt ordinances authorizing code enforcement officers to administer enforcement of certain provisions relating to vessels at risk of becoming derelict & long-term anchoring permit requirements, respectively; provides that such ordinances may not take effect until reviewed & approved by FWCC; requires FWCC to adopt rules; revises exemption from anchoring limitation area requirements for certain vessels; authorizes municipalities & counties to adopt ordinances to extend boating-restricted areas under certain conditions; requires boundaries of such areas to be clearly marked with specified markers. Rec./Crime Victims: Expands public records exemption for crime victims to include name & personal identification number of victim & any other information or record that could be used to locate, intimidate, harass, or abuse victim or victim's family; provides that such exemption includes records generated by any agency that regularly generates information from or concerning victims of crime; provides that certain records identifying law enforcement officers who are involved in use of force incident are confidential & exempt for specified timeframe; specifies requirements for extending such timeframe; provides for future legislative review & repeal of exemptions; provides statement of public necessity. **HB 1121****Aging and Disability Services** by Rizo

Effective Date: July 1, 2026

**HB 1217****Prohibited Governmental Policies Regulating Greenhouse Gas Emissions** by Snyder

Prohibited Governmental Policies Regulating Greenhouse Gas Emissions: Prohibits governmental entities from adopting certain net zero policies; prohibits governmental entities from using public funds in any manner that supports, implements, or advances certain net zero policies; prohibits governmental entities from imposing any charge to advance certain net zero policies; requires each governmental entity to annually submit to Department of Revenue certain affidavit; prohibits

governmental entities from implementing, administering, or enforcing certain programs. Effective Date: July 1, 2026

**HB 1219**     **Waterbody Designations** by Snyder

Waterbody Designations: Designates Andrew "Red" Harris Spoil Island; directs DEP to erect suitable markers. Effective Date: July 1, 2026

**HB 1245**     **Biosolids Management** by Shoaf

Biosolids Management: Prohibits land application of Class AA biosolids fertilizer & compost products from exceeding appropriate agronomic rate; requires land application site owners & operators to maintain records; requires DEP to provide certain notice to such owners & operators & to adopt rules; requires University of Florida's IFAS to publish & make publicly available recommended agronomic rates for bulk Class AA biosolids fertilizer & compost products; authorizes bulk Class AA biosolids or biosolids products to be distributed or marketed as fertilizer & land applied if specified requirements are met; authorizes bulk Class AA biosolids compost products to be distributed or marketed as soil amendments & land applied if specified requirements are met; requires that certain bulk Class AA biosolids compost & fertilizer products be applied at certain land application sites; requires certain bulk Class AA products applied on certain lands meet certain requirements before application. Effective Date: November 1, 2026

**HB 1293**     **Fraudulent Entry of Residential Dwellings** by Greco

Fraudulent Entry of Residential Dwellings: Creates crime of fraudulent entry of residential dwelling unit; prohibits person from entering into & taking possession of residential dwelling unit; provides criminal penalty; provides that fraudulent entry of residential dwelling unit is act of noncompliance for which landlord may terminate rental agreement. Effective Date: October 1, 2026

**HB 1329**     **Local Government Spending** by Benaroch

Local Government Spending: Revises length of time tentative budgets & final budgets must be posted on county, municipality, & special district websites; requires posting of such budgets to allow members of public to download & review certain information & data in specified formats; requires county and municipal budget officer to perform certain exercise before final adoption of budget; revises length of time adopted amendment must be posted on county's & municipality's website; requires posting of proposed amendment to meet certain requirements; provides exception for counties & municipalities that meet certain requirements; requires counties & municipalities that meet such exception to provide information in form & manner prescribed by DFS; authorizes counties & municipalities to apply for certain hardship waivers. Effective Date: July 1, 2026

**HB 1337**     **Estates** by Tuck

Estates: Revises provisions related to estates including exemptions from filing fees, access to safe-deposit boxes, termination of leases, rights, responsibilities, & duties of personal representatives, summary administration, income tax refunds & attorney fees, payments to successors, administration of intestate small estates. Effective Date: July 1, 2026

**HB 1343**     **Insurance Customer Representative Licensing Qualifications** by Hodgers

Insurance Customer Representative Licensing Qualifications: Revises methods by which applicants can qualify for customer representative license. Effective Date: July 1, 2026

**HB 1347**     **Clinical Laboratory Personnel** by Gerwig

Clinical Laboratory Personnel: Requires that applicant who qualifies for licensure under specified provisions provide proof of such qualification & pay required fees to be eligible for licensure; requires that applicants for licensure as technologist or technician who meet specified criteria be

deemed to have satisfied minimum qualifications for licensure to perform high or moderate complexity testing as technologist or technician, as applicable. Effective Date: July 1, 2026

**HB 1389**     **Affordable Housing** by Redondo

Affordable Housing: Authorizes multifamily & mixed-use residential uses as allowable uses for specified property; provides requirements for certain proposed developments; prohibits counties & municipalities from having certain restrictions or requiring certain setbacks; requires adoption of certain ordinances relating to accessory dwelling units; prohibits such ordinances from including certain requirements; provides exception to certain local governments; removes requirement for specified affidavit in building permit application; prohibits owners of certain property from being denied homestead exemption; requires certain accessory dwelling units to be assessed & taxed separately; authorizes applicants for certain proposed developments to proceed under certain provisions of law; requires counties & municipalities to allow certain applicants to submit revised applications, written requests, or notices of intent; provides that specified provisions of law relating to proposed developments do not apply to airport zoning regulations unless approved by governing body; authorizes local governments to provide certain incentives to landowners who donate property to provide affordable housing for military families; prohibits certain discriminatory practices based on financing of development for affordable housing; waiving state's sovereign immunity for certain causes of action; requires OPPAGA to evaluate certain methods to stimulate construction & use of tiny homes for specified purpose & submit to Legislature certain report. **HB 1405**     **Statewide Project for Missing Persons with Special Needs** by Duggan

Deductions for Certain Losses of Alcoholic Beverages: Authorizes distributor of vinous, spirituous, or malt beverages to make excise tax deduction in its monthly tax report for alcoholic beverages that have become unsellable through warehouse breakage, spoliation, evaporation, or expiration or that have become unfit for human consumption; requires distributors that distribute more than one type of alcoholic beverage to deduct their gross taxes for products according to those specified in specified manner; excludes extraordinary losses of vinous, spirituous, or malt beverages from such deductions; authorizes distributor to deduct actual gallonage of extraordinary loss. Effective Date: upon becoming a law

**HB 1217 Prohibited Governmental Policies Regulating Greenhouse Gas Emissions** by Snyder

Prohibited Governmental Policies Regulating Greenhouse Gas Emissions: Prohibits governmental entities from adopting certain net zero policies; prohibits governmental entities from using public funds in any manner that supports, implements, or advances certain net zero policies; prohibits governmental entities from imposing any charge to advance certain net zero policies; requires each governmental entity to annually submit to Department of Revenue certain affidavit; prohibits governmental entities from implementing, administering, or enforcing certain programs. Effective Date: July 1, 2026

**HB 1311 Legal Tender** by Bankson

Legal Tender: Ratifying specified rules relating to legal tender for the sole and exclusive purpose of satisfying any condition on effectiveness of provisions and repealing provisions relating to legal tender, etc. Effective Date: upon becoming a law

**HB 1343 Insurance Customer Representative Licensing Qualifications** by Hodgers

Insurance Customer Representative Licensing Qualifications: Revises methods by which applicants can qualify for customer representative license. Effective Date: July 1, 2026

**SB 1452 Department of Financial Services** by Truenow

Department of Financial Services; Revising the subsystem used for a certain report of disbursements made; deleting the Department of Financial Services' authority to make semimonthly salary payments; revising eligibility requirements for a hurricane mitigation inspection under the My Safe Florida Home Program; revising eligibility requirements for the My Safe Florida Condominium Pilot Program; providing that redemption in cash or through a debit card transaction shall be treated the same; revising the timelines and conditions under which stock, other equity interests, or debt of a business association is considered abandoned; ratifying specified rules relating to legal tender for the sole and exclusive purpose of satisfying conditions on effectiveness pursuant to chapter 2025-100, Laws of Florida, etc. Effective Date: Upon becoming a law

**HB 4005 City of Naples Airport Authority, Collier County** by Botana

City of Naples Airport Authority, Collier County: Removes provisions relating to City of Naples Airport Authority's members' duties & responsibilities; removes provisions that prohibit officers & employees of city from being authority members; removes provisions that prohibit authority members from receiving compensation; provides for authority memberships by election rather than by appointment; provides requirements for elections; provides authority membership terms & qualifications; provides interim services & vacancy fillings. Effective Date: upon becoming a law

**HB 4039 Solid Waste Disposal Facility in Broward County** by Daley

Solid Waste Disposal Facility in Broward County: Defines "Monarch Hill Landfill"; requires feasibility study & public hearing before any expansion of Monarch Hill Landfill; provides requirements for study & public hearing. Effective Date: October 1, 2026

**HB 7031 Internal Revenue Code** by Ways & Means Committee

Internal Revenue Code : Revises the definition of the term "Internal Revenue Code"; conforms provisions to changes made by the act; provides for retroactive application; requires the Department of Revenue to adopt rules; authorizes the department to adopt emergency rules. Effective Date: upon becoming a law
